## ELEXICON ENERGY INC.

## Application for changes to electricity distribution rates in the Veridian Rate Zone and the Whitby Rate Zone, effective January 1, 2023

## PROCEDURAL ORDER NO. 1 September 12, 2022

ELEXICON ENERGY INC. (Elexicon Energy) filed an incentive rate-setting mechanism application and request for incremental capital funding with the Ontario Energy Board (OEB) on July 28, 2022, under section 78 of the *Ontario Energy Board Act*, *1998*, seeking approval for changes to its electricity distribution rates in the Veridian and Whitby rate zones, effective January 1, 2023.

A Notice of Hearing was issued on August 16, 2022. Each of Brooklin Landowners Group Inc. (Brooklin Landowners), Consumers Council of Canada (CCC), Coalition of Concerned Manufacturers and Businesses of Canada (CCMBC), Power Workers' Union (PWU), Small Business Utility Alliance (SBUA), School Energy Coalition (SEC)<sup>1</sup> and Vulnerable Energy Consumers Coalition (VECC) applied for intervenor status. CCC, CCMBC, SBUA, SEC and VECC also applied for cost eligibility.

No objection was received from Elexicon Energy.

Brooklin Landowners, CCC, CCMBC, PWU, SBUA, SEC and VECC are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order. CCC, CCMBC, SBUA, SEC and VECC are eligible to apply for an award of costs under the OEB's <u>Practice Direction on Cost Awards</u> and only in relation to Elexicon Energy's requests for incremental capital funding and adjustments to Account 1595.

Cost eligible intervenors should be aware that the OEB will not generally allow for the recovery of costs for the attendance of more than one representative of any party unless a compelling reason is provided when cost claims are filed.

Being eligible to apply for recovery of costs is not a guarantee of recovery of any costs claimed. Cost awards are made by way of OEB order at the end of a hearing.

## Type of Hearing

In each of their letters of intervention, SEC and SBUA noted that it would be premature for the OEB to make a determination on the type of hearing prior to the completion of the interrogatory process. CCMBC noted that it may be possible to resolve all issues through a settlement conference and the OEB should consider making provision for a settlement conference. The OEB Panel will make a determination on the next steps after the filing of interrogatory responses.

## THE ONTARIO ENERGY BOARD ORDERS THAT:

- 1. OEB staff and intervenors shall request any relevant information and documentation from Elexicon Energy that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Elexicon Energy and all other parties by **September 29, 2022**.
- 2. Elexicon Energy shall file with the OEB complete written responses to the interrogatories and serve them on all intervenors by **October 13, 2022**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
