## Dear Applicants:

Re: Issuance of the Electricity Distribution Licence, Cancellation of Licences and Transfer of Rate Orders

OEB File Number: EB-2022-0006

On June 28, 2022, the OEB issued a Decision and Order approving the amalgamation of Kitchener-Wilmot Hydro Inc. (Kitchener-Wilmot Hydro) and Waterloo North Hydro Inc. (Waterloo North Hydro). In its decision, the OEB stated that upon receiving notification of the completion of the transaction, the OEB would:

- a) Issue the new electricity distribution licence the new amalgamated entity LDC MergeCo to include the service areas formerly served by Kitchener-Wilmot Hydro and Waterloo North Hydro;
- b) Cancel the electricity distribution licences of Kitchener-Wilmot Hydro (ED-2002-0573) and Waterloo North Hydro (ED-2002-0575); and
- c) Transfer the rate orders of Kitchener-Wilmot Hydro and Waterloo North Hydro to the new amalgamated entity LDC MergeCo.

On September 9, 2022, Kitchener-Wilmot Hydro and Waterloo North Hydro notified the OEB that the amalgamation transaction was completed on September 1, 2022 and the new amalgamated entity LDC MergeCo was incorporated under the name Enova Power Corp.

Please find enclosed the electricity distribution licence ED-2022-0006 issued under the name Enova Power Corp. with effective date September 1, 2022. The electricity distribution licences of Kitchener-Wilmot Hydro (ED-2002-0573) and Waterloo North Hydro (ED-2002-0575) are cancelled, effective September 1, 2022.

Pursuant to the decision and order, the rate order of Kitchener-Wilmot Hydro, dated December 16, 2021, and the rate order of Waterloo North Hydro, dated December 9, 2021, are transferred to Enova Power Corp.
