## EB-2022-0041 – Confidential filing for Hydro One Remote Communities Inc. 2023 Cost of Service Application

On August 31, 2022 Hydro One Remote Communities Inc. (Remotes) filed its 2023 Cost of Service Application. Pursuant to Rule 9A and 10 of the Ontario Energy Board's (OEB) *Rules of Practice and Procedure* (the Rules) and the OEB's *Practice Direction on Confidential Filings* (the Practice Direction), Hydro One hereby requests the confidential treatment of certain information contained in Remotes' 2020 and 2021 Corporate Tax Return, filed as Attachments 1 and 2 to Exhibit D, Tab 5, Schedule 2.
