**Re: North Bay Hydro Distribution Limited - Extension of CDM Activities
Beyond September 30, 2007**

We are counsel to North Bay Hydro Distribution Limited ("North Bay Hydro"). On June 14, 2007, we wrote to you to convey North Bay Hydro's request that the OEB extend the deadline for completion of the Commercial, Industrial and Institutional Demand Management activities that form part of North Bay Hydro's Conservation and Demand Management ("CDM") Plan to the end of the current rate year (April 30, 2008) and allow North Bay Hydro to execute agreements with customers interested in participating in those portions of the CDM Plan until December 31, 2007. A copy of that letter is enclosed, for your reference.

Further to an exchange of voicemail messages with Board staff, we take this opportunity to confirm that North Bay Hydro requests that this matter be addressed and disposed of by the Board without a hearing, pursuant to subsection 21(4) of the *Ontario Energy Board Act, 1998*. North Bay Hydro submits that no person, other than North Bay Hydro itself, will be adversely affected in a material way by the outcome of the proceeding (we note that "3rd Tranche" CDM funds are already included in North Bay Hydro's electricity distribution rates). North Bay Hydro consents to the disposition of this proceeding without a hearing.
