- 2. To post a copy of each of the English, French, Cree, Oji-Cree and Ojibway versions of the Notice, the application and the evidence, and any amendments thereto, on Hydro One Remotes' website.
- 3. To arrange for the service of the enclosed English, French, Cree, Oji-Cree and Ojibway versions of the Notice, in the exact form accompanying this letter by email on any customers for which Hydro One Remotes has an email address and

appropriate permissions to use the email address to send utility or regulatory information with the following email messages:
