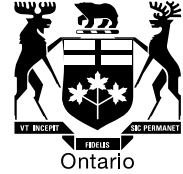

EB-2007-0652 – Great Lakes Power Limited – Application for an order granting leave to transfer its Leave to Construct Order in RP-2003-0120/EB-2003-0162 to Great Lakes Power Transmission LP.
