# NOTICE OF APPLICATION AND WRITTEN HEARING TOROMONT ENERGY LTD. APPLICATION FOR AMENDMENT OF ELECTRICITY GENERATION LICENCE

Toromont Energy Ltd. filed an application with the Ontario Energy Board on May 17, 2007 under section 74 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c. 15, Schedule B.

The applicant has applied to amend Schedule 1 of its electricity generation licence, EG-2003-0163. The following is a summary of the requested Schedule 1 amendments:

- removing two facilities for which the applicant is the current licensed owner and operator;
- adding three facilities for which the applicant has applied to be the licensed owner and operator; and
- adding four facilities for which the applicant has applied to be the licensed operator. These facilities include the Eastview Landfill Gas Energy Plant for which Ecotricity Guelph Inc. is the current licensed owner and operator, and the Woodward Digester Gas Power Plant for which Hamilton Renewable Power Inc. is the current licensed owner and operator.

The Board has assigned the application file no. EB-2007-0636. The application will be decided by the Special Advisor, Market Operations who has been delegated this authority pursuant to section 6 of the Act. The Special Advisor does not intend to provide for an award of costs when deciding this application.

Copies of the application and the pre-filed evidence in support of Toromont Energy Ltd.'s application will be available for public inspection at the Board's offices, and at the applicant's offices (addresses below).

# How to Participate in the Hearing

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant within 10 days of the date this notice was served.

If you wish to participate in the written hearing, please file a written submission setting out your views on the application. You must forward three paper copies, and if possible, an electronic copy in Word format and in searchable PDF format, of your submission to the Board and one copy to the applicant at the addresses below. All submissions must be received no later than 21 days after the date this notice was served. If Toromont Energy Ltd. wishes to respond to the submissions, such response must be filed with the Board and copied to any party that made submissions no later than 28 days after the date this notice was served.

All submissions must quote file no. EB-2007-0636, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
