## ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF CHAPLEAU PUBLIC UTILITIES CORPORATION

# Chapleau Public Utilities Corporation has applied to change its electricity distribution rates effective May 1, 2023.

### Learn more. Have your say.

Chapleau Public Utilities Corporation has applied to the Ontario Energy Board to increase the electricity distribution rates of certain customer classes effective May 1, 2023. If the application is approved as filed, a typical residential customer of Chapleau Public Utilities will see no change, while a typical general service customer of Chapleau Public Utilities Corporation will see the following increase:

Rate Class	Monthly Bill Impact
Residential 750 kWh	No Impact
General Service less than 50 kW (2,000 kWh)	\$2.67 per month

Other customers, including businesses may be affected.

The requested rate increase is set using an OEB-approved formula which is tied to inflation and other factors intended to promote efficiency.

Chapleau Public Utilities Corporation states that its 2021 earnings were in excess of the threshold set by the Ontario Energy Board. The Ontario Energy Board will review Chapleau Public Utilities Corporation's request for an increase in the context of its reported over earnings.

#### THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Chapleau Public Utilities' application. We will determine whether the company has used the applicable models and formulas required by the OEB and whether to approve Chapleau Public Utilities' request for a rate adjustment, given the reported over earnings. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process

- You can review Chapleau Public Utilities' application on the OEB's website now
- You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about Chapleau Public
- Utilities' application and make arguments on whether the OEB should approve Chapleau Public Utilities' request. Apply by **November 17, 2022** or the hearing will go ahead without you and you will not receive any further notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

The OEB does not intend to consider cost awards for this hearing.

These proposed charges relate to Chapleau Public Utilities' distribution services. They make up part of the Delivery line - one of the line items on your bill. #### **ORAL VS. WRITTEN HEARINGS**

There are two types of OEB hearings – oral and written. Chapleau Public Utilities has applied for a written hearing. The OEB intends to proceed by way of a written hearing in this case. If you think an oral hearing is needed, you can write to the OEB to explain why by **November 17, 2022**.

#### PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be

removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.
