## **DECISION AND ORDER ON COST AWARDS**

## EB-2021-0118

Framework for Energy Innovation: Distributed Resources and Utility Incentives

By Delegation Before: Brian Hewson Vice President, Consumer Protection & Industry Performance

#### OVERVIEW

On March 23, 2021, the OEB issued a <u>letter</u> confirming that cost awards would be available for participating in the OEB's Framework for Energy Innovation (FEI): Distributed Resources and Utility Incentives consultation, under section 30 of the *Ontario Energy Board Act, 1998*, and costs would be recovered as follows:

- 80% from all rate-regulated licensed electricity distributors
- 20% from all rate-regulated licensed electricity transmitters

The following organizations are eligible for an award of costs in relation to cost-eligible activities (collectively the Eligible Participants):<sup>1</sup>

- Anwaatin Inc. (Anwaatin)
- Association of Major Power Consumers in Ontario (AMPCO)
- Building Owners and Managers Association Toronto (BOMA)
- Canadian Manufacturers & Exporters (CME)
- Consumers Council of Canada (CCC)
- Energy Probe Research Foundation (Energy Probe)
- Electric Vehicle Society (EVS)
- Environmental Defence
- Industrial Gas Users Association (IGUA)
- London Property Management Association (LPMA)
- Ontario Chamber of Commerce (OCC)
- Pollution Probe
- School Energy Coalition (SEC)
- Vulnerable Energy Consumers Coalition (VECC)

In accordance with the OEB's Cost Assessment Model, the OEB will apportion costs amongst the distributors based on customer numbers, and amongst the transmitters based on revenues.

On September 12, 2022, the OEB issued its Notice of Hearing for Cost Awards (<u>September 2022 Notice</u>) in which it set out the activities undertaken between February 1, 2022, and September 2, 2022, and the process for cost claims.

The OEB received cost claims from Anwaatin, AMPCO, BOMA, CME, CCC, Energy Probe, EVS, Environmental Defence, IGUA, LPMA, OCC, Pollution Probe and SEC. VECC did not file a cost claim. No objections were received.

#### Findings

The OEB has reviewed the cost claims filed to ensure they are compliant with the OEB's *Practice Direction on Cost Awards*.

The OEB approves the cost claims as filed by Anwaatin, AMPCO, BOMA, CME, CCC, Energy Probe, Environmental Defence, IGUA, LPMA, OCC and SEC.

The cost claim submitted by EVS includes 1.7 hours for attending the OEB/IESO Joint Engagement on Distributed Energy Resources Integration session on April 13, 2022. The April 2022 OEB/IESO session was not included in the list of eligible activities in the September 2022 Notice. The OEB has therefore reduced EVS' claim by 1.7 hours associated with the April 2022 OEB/IESO session. The OEB intends to issue a separate Notice dealing specifically with those activities in due course.

Pollution Probe's cost claim includes 6 hours for attending FEI Working Group meeting #21 on June 29, 2022. In responding to OEB staff questions, Pollution Probe affirmed those hours were submitted in error. The OEB has therefore removed that portion of Pollution Probe's claim.

The OEB also approves an amount of \$18,839.40 for recovery from rate-regulated electricity distributors and rate-regulated electricity transmitters (rate-regulated utilities) associated with the OEB's costs of and incidental to this consultation.

#### **Process for Paying the Cost Awards**

The amount payable by each rate-regulated utility in relation to costs awarded to each eligible participant is listed in Schedule A to this Decision and Order. The amounts will not be paid directly by the rate-regulated utilities to the eligible participants.

The OEB will use the process set out in section 12 of the *Practice Direction on Cost Awards* to implement the payment of the approved cost awards whereby the OEB will act as a clearing house for all payments of cost awards. Consistent with this process, each rate-regulated utility is issued one invoice that covers all cost awards payable for the relevant period. As a result, the invoice may cover cost awards payable in relation to several proceedings and consultations, including this proceeding. The invoice will be sent out at the same time as the invoices for cost assessments under section 26 of the OEB Act are sent out, and payment will be due at the same time that cost assessments are due.

#### THE ONTARIO ENERGY BOARD ORDERS THAT:

1. Each rate-regulated utility in Schedule A to this Decision and Order shall make a payment to the OEB in accordance with the amounts set out in Schedule A, upon receiving an invoice from the OEB.
