**Enbridge Gas Inc.**

**Application for Multi-Year Natural Gas Demand Side  
Management Plan (2022 to 2027)**

**CONFIDENTIALITY DECISION AND  
PROCEDURAL ORDER NO.8  
November 11, 2022**

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) for approval of a new natural gas demand side management (DSM) policy framework, effective January 1, 2022, as well as approval of a new multi-year DSM plan, inclusive of budgets, programs and targets from January 1, 2022 to December 31, 2027.

The Ontario Energy Board (OEB) will issue its decision on Enbridge Gas's application for approval of a multi-year natural gas DSM plan (DSM Decision) on Tuesday, November 15, 2022. For the reasons explained below, the DSM Decision will initially be provided to parties to the proceeding on a confidential basis. The DSM Decision will be released publicly on November 21, 2022, and parties to the proceeding will be directly notified accordingly.

In its Partial Decision on Confidentiality and Procedural Order No. 7 dated September 9, 2022, the OEB addressed Enbridge Gas's request for temporary confidential treatment of its agreement with Natural Resources Canada for delivery of a joint residential whole home program in Ontario (EGI-NRCan Agreement) pending the public announcement of the joint program. In making its request, Enbridge Gas explained that confidential treatment was sought to avoid public confusion between the current programs being delivered by Enbridge Gas and Natural Resources Canada and the new joint program that might compromise the efficiency of the start-up of the new joint program. The OEB accepted Enbridge Gas's request and also extended confidential treatment to submissions made by the parties on the implications of the EGI-NRCan Agreement. The OEB also noted that the EGI-NRCan Agreement "sets out certain program details that may necessitate change depending on the OEB's Decision on Enbridge Gas's application and its proposed Residential Whole Home offering." The DSM Decision references information in respect of which the OEB has granted temporary confidential treatment.

The OEB will require parties to the proceeding to sign a Declaration and Undertaking specifically designed for this unique circumstance in order to receive a copy of the DSM Decision prior to its public release on November 21, 2022. Parties that wish to

receive the DSM Decision prior to November 21, 2022, including those that have already signed the standard Declaration and Undertaking in this proceeding, will be required to return a signed copy of the new Declaration and Undertaking attached as Schedule A to this Procedural Order to the following e-mail address:

Party representatives who have signed and returned the new Declaration and Undertaking will receive a link to a view only copy of the DSM Decision.

Temporary confidential treatment for the DSM Decision, the EGI-NRCAN Agreement and related submissions will expire at the time of the public release of the DSM Decision on November 21, 2022. By end of day on November 17, 2022, the OEB will confirm with the parties the time for the public release of the DSM Decision on November 21, 2022.

### THE ONTARIO ENERGY BOARD ORDERS:

1. Any party representative seeking access to the DSM Decision prior to its public release on November 21, 2022 must return a signed copy of the Declaration and Undertaking attached as Schedule A to this order to the following email address: [registrar@oeb.ca](mailto:registrar@oeb.ca).
2. No party representative gaining access to the DSM Decision prior to November 21, 2022 shall provide any other person with a copy of the DSM Decision without prior approval of the OEB.
3. The temporary confidential treatment for the EGI-NRCAN Agreement and related submissions, and the obligations under the Declaration and Undertaking will expire at the time of the public release of the DSM Decision on November 21, 2022.
