Re: Enbridge Gas Inc. (Enbridge Gas)

2024 Rebasing Application

Ontario Energy Board File Number: EB-2022-0200

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Enbridge Gas's above-referenced application (Notice). The English and French versions of the Notice will be published by the OEB, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 through 4 below **prior to November 22, 2022**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at registrar@oeb.ca.

You are directed:

- To post a copy of both the English and French versions of the Notice, the application and the evidence, and any amendments thereto, on Enbridge Gas's website.
- 2. To arrange for the service of each of the enclosed English and French versions of the Notice, in the exact form accompanying this letter and the application and the evidence, directly on:
 - i. the clerks of all municipalities in which Enbridge Gas supplies gas;
 - ii. the band councils of all Indigenous communities and First Nation Reserves to which Enbridge Gas supplies gas;

iii. the Métis Nation of Ontario:

- iv. all intervenors of record in the MAADs proceeding, EB-2017-0306/EB-2017-0307; and the recent Incentive Rate-setting Mechanism proceeding, EB-2022-0133
- v. all natural gas distributors in Ontario that take natural gas service from Enbridge Gas.
- 3. To arrange for the service of the enclosed English and French versions of the Notice, in the exact form accompanying this letter by email on any customers for which Enbridge Gas has an email address and appropriate permissions to use the email address to send utility or regulatory information with the following email messages:
 - i. "Enbridge Gas Inc. has applied to the Ontario Energy Board to change our natural gas rates. Please review the Ontario Energy Board's Notice of Hearing to learn more and to find out how you can participate in the Ontario Energy Board's hearing." The email must include the words "Notice of Hearing" within the email message and provide a live link to the English Notice posted on Enbridge Gas's website.
 - ii. « Enbridge Gas Inc. a déposé une requête auprès de la Commision de l'énergie de l'Ontario afin de modifier nos tarifs de gaz naturel. Veuillez lire l'avis d'audience ci-joint pour vous mieux renseigné et pour savoir comment participer au processus d'audience du tribunal. » The email must include the words « l'avis d'audience » within the email message and provide a live link to the French Notice posted on Enbridge Gas's website.
- 4. If Enbridge Gas has a twitter account, once both the English and French versions of the Notice are posted on Enbridge Gas's website in accordance with paragraph 1, to tweet the following messages:
 - i. "We have applied to the @OntEnergyBoard to change our natural gas rates. Learn more. Have your say." The tweet is required to provide a live link to the English Notice posted on Enbridge Gas's website.
 - ii. « Nous avons déposé une requête auprès de @OntEnergyBoard afin de modifier nos tarifs de gaz naturel. Soyez mieux renseigné. Donnez votre opinion. » The tweet is required to provide a live link to the French Notice posted on Enbridge Gas's website.
- 5. To file with the OEB an affidavit proving completion of the matters in paragraphs 1 through 4 above immediately thereafter.

6. To provide a copy of the Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
