IRM Rate Generator Model, Tab 3 & Tab 18

Preamble: RHI correctly separated the LRAM-eligible amounts for 2023 from the LRAMVA balance in Tab 3 of the IRM Rate Generator Model. However, RHI did not populate Tab 18 of the IRM Rate Generator Model with the 2023 rate rider for 2023, adjusted by the inflation minus x-factor to this balance to determine the final rate rider.

Questions:

a) Please update Tab 18 of the IRM Rate Generator Model

Renfrew Hydro Inc. - Response

Renfrew Hydro Inc. (RHI) has updated Tab 18 of the IRM Rate Generator Model and provided the calculations below. RHI used the OEB approved 2023 inflationary factor less the X-factor in the calculations (3.70% - 0.30% = 3.40%).

RHI also confirms acceptance of the revised IRM Rate Generator Model and confirms the following updates from OEB staff have been applied correctly:
