



Enbridge Gas Inc.

**Application for a franchise renewal with, and certificate
amendment for, the Municipality of Leamington**

**PROCEDURAL ORDER NO. 2
November 18, 2022**

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) on June 30, 2022, seeking orders under sections 8, 9(4) and 10 of the *Municipal Franchises Act* for a franchise renewal with, and an amendment to its certificate of public convenience and necessity for, the Municipality of Leamington (Municipality).

The Municipality filed its evidence on November 8, 2022 in accordance with the schedule established in Procedural Order No. 1. The evidence provided detail on the various drainage systems in the Municipality.

On November 10, 2022, Enbridge Gas filed interrogatories on the Municipality's evidence and confirmed its intention to file reply evidence in the proceeding. Enbridge Gas requested until December 13, 2022, to file its reply evidence.

The OEB is providing Enbridge Gas the opportunity to file reply evidence in accordance with the schedule established in this procedural order. The OEB is also providing for a written argument-in-chief, written submissions by OEB staff and the Municipality, and a reply submission by Enbridge Gas in this procedural order.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Municipality shall file with the OEB complete written responses to all interrogatories with respect to its evidence and deliver those responses to all parties by **November 29, 2022**.
2. Enbridge Gas shall file its reply evidence, with the OEB and serve it on all parties by **December 13, 2022**.

3. OEB staff and the Municipality shall request any relevant information and documentation from Enbridge Gas that is in addition to its filed evidence, by written interrogatories filed with the OEB and served on all parties by **January 12, 2023**.
4. Enbridge Gas shall file with the OEB complete written responses to all interrogatories and serve them on all parties by **January 24, 2023**.
5. Enbridge Gas shall file its argument-in-chief with the OEB and send to all parties by **February 3, 2023**.
6. OEB staff and the Municipality shall file their written submissions with the OEB and serve them on all parties by **February 21, 2023**.
7. Enbridge Gas shall file a written reply submission, if any, with the OEB and serve it on all parties by **March 3, 2023**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
