RE: EB-2022-0110 EGI 2021 Deferral Dispositions - FRPO Cost Claim Support

We are writing on behalf of the Federation of Rental-housing Providers of Ontario (FRPO) in support of our cost claim in the EGI 2021 Deferral Disposition proceeding.

Given our focus on natural gas in the OEB's proceedings, we view Deferral Disposition proceedings as an opportunity, to the extent possible, that ratepayers, including our members, are getting what they paid for in terms of actual performance from the utility. As time has passed since the merger of the utilities and even more since their last rebasing proceedings, the evaluation of the reporting in the application has become more challenging. As a result, we have invested more time in the understanding and discovery regarding these accounts including IR's submitted on confidential evidence.

This year our discovery had an added measure of complexity. Across the Gas Supply proceeding¹ and the most recent QRAM², FRPO has pursued understanding of contracting decisions taken by EGI in increasing ratepayer cost for deliveries from Chicago via Vector pipeline. We outlined the challenge of that pursuit in submissions to the Board in the most recent QRAM proceeding³. In the current proceeding, we strived to access data from EGI to complete the picture resulting in provisions in the Settlement Agreement for enhanced reporting in the 2022 Deferrals proceeding.

Further, we invested time assisting our fellow intervenors on the Vector issue and other issues arising from our discovery. As a result, our investment of time in this proceeding will likely significantly exceed our fellow ratepayer representatives.

We remain available if the Board has any specific questions or concerns regarding our cost claim.
