#### Re: EB-2022-0086 - Enbridge Dawn-Corunna LTC - SEC Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the Board's form with accompanying detailed dockets.

This was a significant leave to construct application for a project that is expected to cost ~\$250M. The evidence included considerable detailed technical information regarding asset health and reliability that had to be reviewed and understood. We note that several intervenors in their own final submissions relied on SEC's analysis of issues related to reliability and the claimed urgent need for the project.

For the purposes of completing the cost claim, all time claimed for the undersigned as of September 2022 have been included as a separate participant, to reflect the change in the hourly rate related to the change in the number of completed years of practicing, pursuant to the *Practice Direction on Cost Awards*. As well, we have reviewed all docketed time to ensure SEC's claim is reasonable, and have decided not to claim a significant amount of time (~50 hours) spent by junior counsel Fred Zheng.
