# EO GENERATION LP BY ITS GENERAL PARTNER EO GENERATION GP INC.

## CANADIAN HYDRO DEVELOPERS, INC.

Application for an Electricity Generation Licence Amendments

### **Decision and Order**

EO Generation LP by its general partner EO Generation Inc. (EO Generation) and Canadian Hydro Developers, Inc. (Canadian Hydro Developers) both filed applications on November 16, 2022, with the Ontario Energy Board (OEB) pursuant to section 74 of the *Ontario Energy Board Act*, *1998* (OEB Act), to amend Schedule 1 of their respective electricity generation licences: EG-2012-0091 and EG-2003-0134. Schedule 1 of a generation licence lists the licensee's generation facilities and the ownership and/or operational authorizations granted by the OEB with respect to those facilities.

Given their related nature, the OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act. This Decision and Order is being issued by the Delegated Authority without a hearing pursuant to section 6(4) of the OEB Act.

Canadian Hydro Developers is seeking an amendment that would remove from Schedule 1 of its licence EG-2003-0134 the following facilities:

- Galetta Hydroelectric Generating Station located at 3278 Galetta Side Road, Galetta, Ontario.
- Appleton Hydroelectric Generating Station located at 100 Old Mill Road, R.R. #3 Almonte, Ontario.

At the same time, EO Generation is seeking to have these two facilities added to Schedule 1 of its licence EG-2012-0091.

The applications were filed as a result of a commercial transaction that would result in the acquisition by EO generation purchasing the above-mentioned electricity generation facilities, currently owned and operated by Canadian Hydro Developers.

The OEB finds that the applications should be granted. There are no amendments to the two licences beyond the changes to Schedule 1.

### IT IS ORDERED THAT:

- 1. EO Generation LP by its general partner EO Generation Inc.'s application to amend Schedule 1 of its electricity generation licence EG-2012-0091 is granted. A copy of the licence, as amended, is attached to this Decision and Order.
- 2. Canadian Hydro Developers, Inc.'s application to amend Schedule 1 of the electricity generation licence EG-2003-0134 is granted. A copy of the licence, as amended, is attached to this Decision and Order.
