
Schedule 3 List of Code Exemptions

1. The Licensee is exempt from the requirements of section 2.5.3 of the Standard Supply Service Code with respect to the price for small volume/residential consumers, subject to the Licensee offering an equal billing plan as described in its application for exemption from Fixed Reference Price, and meeting all other undertakings and material representations contained in the application and the materials filed in connection with it.
2. The Licensee is exempt from the requirements of section 6.5.4 of the Distribution System Code until:
 - a. December 31, 2009 in relation to nine load transfer customers located at Coates Road West with civic address numbers 245, 291, 345, 405, 433, 451, 655, 775 and 815 in the City of Oshawa;
 - b. December 31, 2010 in relation to six customers located on Townline Road North with civic address numbers 4626, 4580, 4220, 4420, 4336 and 4800 in the City of Oshawa; and
 - c. December 31, 2011 in relation to ten customers located on properties with the following civic addresses: 38 Coates Rd E, 65 Coates Rd E, 285 Coates Rd E, 1500 Ritson Rd N, 5245 Wilson Rd N #1, 5245 Wilson Rd N #2, 3572 Townline Rd N, 1590 Columbus Rd E, 1600 Conlin Rd E, and 1848 Townline Rd N in the City of Oshawa.
