This reflects similar legal resources expended by the proponent of this project, Hydro One Networks Inc. HDI has entirely deducted the time of three other counsel, Thomas Dumigan, Dylan Gibbs, and Jonathan Martin, on this matter.

For these reasons, an award of the submitted costs is appropriate and justified.
