**Re: Enbridge Gas Inc. ("EGI")  
Multi-Year Demand Side Management Plan (2022-2027) Application

We are counsel to the Association of Power Producers of Ontario ("**APPrO**") in the above-noted proceeding (the "**Proceeding**"). Further to the Board's Decision and Order dated November 15, 2022, please find enclosed APPrO's cost claim in respect of the Proceeding.

APPrO respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Proceeding. APPrO submits that this request is supported by the following considerations:

- (a) APPrO participated effectively in the Proceeding, taking a surgical, principled, and coordinated approach to matters related to DSM programming for large volume customers and gas-fired generators, and energy conservation and efficiency and assisted in contributing to the Board's better understanding of such matters;
- (b) APPrO has ensured that it has not requested recovery of costs associated with the attendance of more than one representative at the same time at the oral hearing and notes that the attendance of two representatives on Days 1, 3 and 4 of the oral hearing did not overlap with each other as counsel for APPrO was unable to attend throughout the scheduled time on each of these days and was therefore replaced by another representative to ensure that APPrO was able to fully and effectively participate during the oral hearing;
- (c) APPrO ensured that its participation in the Proceeding was focused on material issues and consistent with the scope of its intervention, as set out in its Notice of Intervention; and
- (d) APPrO participated responsibly and undertook coordination with other intervenors and Board Staff to avoid overlap, maximize efficiency, and ensure that its participation was not unduly repetitive and was focused on relevant and material issues.

We trust that this approach maximizes the efficient use of resources and the right of otherwise unrepresented and important EGI customers to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

APPrO respectfully requests a full award of eligible costs.
