We are counsel to Anwaatin Inc. ("**Anwaatin**") in the above-noted proceeding (the "**Proceeding**"). Further to the Board's Decision and Order dated November 15, 2022, please find enclosed Anwaatin's cost claim in respect of the Proceeding.

Anwaatin respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation reflecting the unique interests of Anwaatin's First Nations members in the Proceeding. Anwaatin submits that this request is supported by the following considerations:

- (a) Anwaatin participated effectively in the Proceeding, taking a surgical, principled, and coordinated approach to the issues and assisted in contributing to the Board's better understanding of such matters;
- (b) Anwaatin ensured that its participation in the Proceeding was focused on material issues and consistent with the scope of its intervention, as set out in its Notice of Intervention; and
- (c) Anwaatin participated responsibly and undertook coordination with other intervenors and Board Staff to avoid overlap, maximize efficiency, and ensure that its participation was not unduly repetitive and was focused on relevant and material issues.

We trust that this approach maximizes the efficient use of resources and the right of otherwise unrepresented and important First Nations and Indigenous customers to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

Anwaatin respectfully requests a full award of eligible costs.
