Dear Ms. Marconi,

Bluewater Power Distribution Corporation ("Bluewater") is filing a Cost of Service Application EB-2022-0016 for 2023 rates. Pursuant to the OEB's Practice Direction on Confidential Filings (the "Practice Direction"), Bluewater is requesting the confidential treatment of certain information contained in its Evidence. There are three requests for Confidential Treatment as follows:
