DECISION AND ORDER ON COST AWARDS

Background

On June 15, 2007, the Ontario Energy Board (the "Board") released for comment a Research Paper prepared by Board staff on the Board's *Affiliate Relationships Code for Electricity Distributors and Transmitters* (the "Electricity ARC"). In the letter accompanying the Research Paper, the Board notified interested parties that cost awards would be available to eligible persons under section 30 of the *Ontario Energy Board Act, 1998* (the "Act") in relation to the provision of comments on the Research Paper, to a maximum of 20 hours, and that any costs awarded would be recovered from all rate-regulated licensed electricity distributors.

On July 10, 2007 the Board issued a Decision on Cost Eligibility (the "Cost Decision") which stated that the following participants were eligible for an award of costs in relation to the provision of comments on the staff Research Paper: Building Owners and Managers Association of Greater Toronto, Consumers Council of Canada, Electrical Contractors Association of Ontario, Energy Probe Research Foundation, HVAC

Coalition, London Property Management Association, Pollution Probe, School Energy Coalition and Vulnerable Energy Consumers Coalition (collectively, the "eligible participants").

On September 19, 2007, the Board issued a Notice of Proposal (the "September Notice") in which it proposed a number of amendments to the Electricity ARC. In the September Notice, the Board notified interested parties that cost awards would be available to eligible persons under section 30 of the Act in relation to their participation in the notice and comment process, to a maximum of 30 hours, and that any costs awarded would be recovered from all licensed electricity distributors and licensed electricity transmitters. The September Notice also indicated that all of the participants found to be eligible for an award of costs pursuant to the Cost Decision would be eligible for an award of costs in relation to the notice and comment process.

On February 11, 2008, the Board issued a Notice of Revised Proposal (the "February Notice") in which the Board proposed further amendments to the Electricity ARC. In the February Notice, the Board notified interested parties that cost awards would be available to the eligible participants in relation to this second phase of the notice and comment process, to a maximum of 20 hours.

On May 16, 2008, the Board issued two Notices of Hearing for Cost Awards, one in relation to cost awards associated with the provision of comments on the staff Research Paper and the other in relation to cost awards associated with the provision of comments on the proposed amendments to the Electricity ARC. On July 24, 2008, the Board gave notice that it was extending the deadline by which licensed electricity distributors and transmitters were required to file any objections they might have to any of the cost claims of the eligible participants.

All of the eligible participants submitted cost claims, other than Pollution Probe who did not file written comments on either the staff Research Paper or the proposed amendments to the Electricity ARC. No objections to the cost claims were received by the Board from any licensed electricity distributor or transmitter.

Board Findings on the Cost Claims of the Eligible Participants

The cost claims filed by each of the eligible participants are within the maximums set by the Board in its June 15, 2007 letter, in the September Notice and/or in the February

Notice, as applicable. The Board finds that each of these eligible participants is entitled to 100% of its reasonably incurred costs of participating in this consultation.

The amount payable by each individual licensed rate-regulated distributor in relation to the costs awarded with respect to the provision of comments on the staff Research Paper is listed in Appendix A to this Decision and Order. The amount payable by each licensed electricity distributor and each licensed electricity transmitter in relation to the costs awarded with respect to the provision of comments on the proposed amendments to the Electricity ARC is listed in Appendix B to this Decision and Order.

Process for Paying Cost Awards

As stated in the Board's June 15, 2007 letter and in the September Notice, the Board will use the process set out in section 12 of its *Practice Direction on Cost Awards* to implement the payment of the cost awards. Therefore, the Board will act as a clearing house for all payments of cost awards relating to this consultation process. Invoices will be issued to distributors at the same time as are invoices for cost assessments made under section 26 of the Act. The practice of the Board is to issue to each distributor one invoice that covers all cost awards payable by the distributor for the relevant period. As a result, the invoice may cover cost awards payable in relation to a number of consultations, including this one.

THE BOARD THEREFORE ORDERS THAT:

- 1. The amounts to be paid by each individual distributor and transmitter in relation to the costs awarded to each eligible participant are as set out in Appendix A and B to this Decision and Order.
- The individual distributors and transmitters listed in Appendix A and B to this Decision and Order shall pay the costs awarded to each of the eligible participants as set out in Appendix A and B.
- 3. The individual distributors listed in Appendix A to this Decision and Order shall pay the Board's costs of, and incidental to, this consultation.
- 4. Payment of cost awards and of the Board's costs referred to in paragraphs 2 and 3 shall be made to the Ontario Energy Board in accordance with the invoice

issued to the individual distributor or transmitter and shall be due at the same time as cost assessments under section 26 of the Act are due.
