

improper purpose.



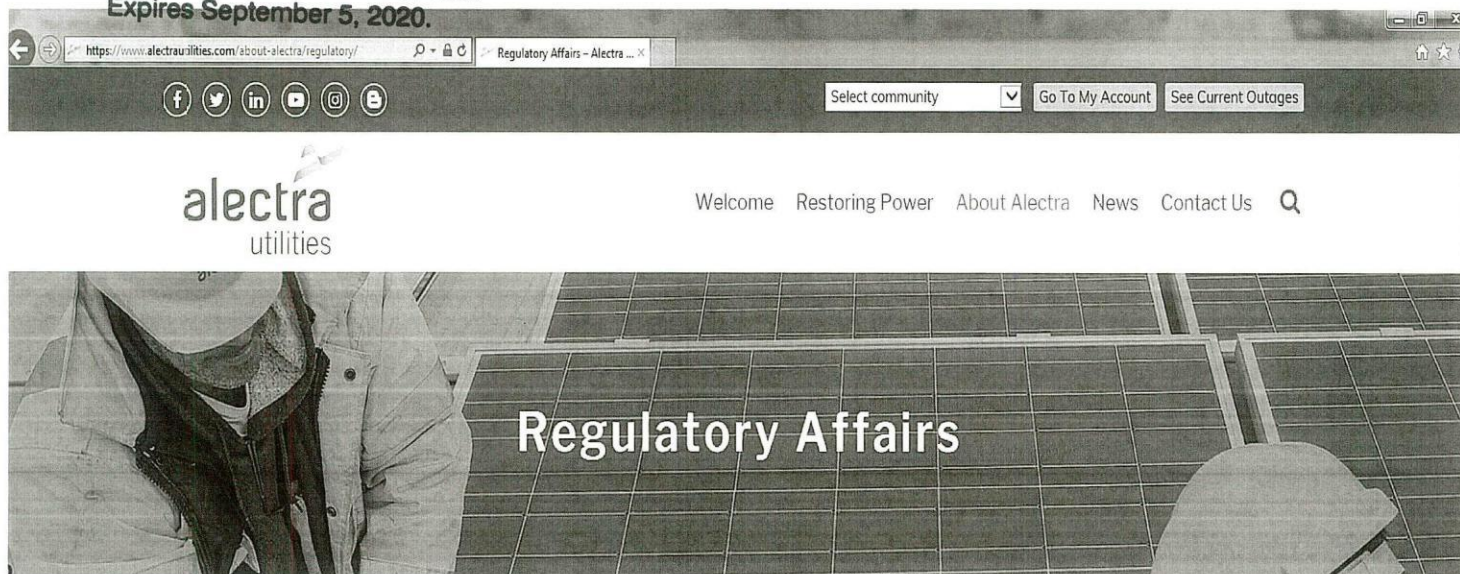
