The Ontario Energy Board has now issued its Notice relating to your 2015-2019 transmission revenue requirement and rates application (the Notice). 2. To immediately make a copy of each of the English and French versions of the Notice, the application and evidence, and any amendments thereto, available for public review at B2M LP's offices and in a prominent place on its website.
3. To file with the Board an affidavit in both electronic and paper forms proving service of the Notice and that a copy of the English and French versions of the Notice, the application and evidence are available for public review at B2M LP's office and on its website.
4. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
