Re: Alectra Utilities Corporation

Application for 2023 Electricity Distribution Rates – Incremental Capital Module Board File No. EB-2022-0013

We are counsel to the Distributed Resource Coalition ("**DRC**") in the above-referenced proceeding (the "**Proceeding**"). Further to the Board's Decision and Order dated November 17, 2022, please find enclosed DRC's cost claim in respect of the Proceeding.

DRC respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Proceeding on behalf of otherwise unrepresented ratepayers with unique interests. DRC submits that this request is supported by the following considerations:

- (i) DRC participated effectively, taking a surgical, principled, and coordinated approach to the issues and undertaking coordination with other intervenors to avoid overlap and maximize efficiency in all aspects of the Proceeding;
- (ii) DRC participated responsibly and made reasonable efforts to ensure that its participation was not unduly repetitive and was focused on relevant and material issues; and
- (iii) DRC contributed to the Board's better understanding of issues in the Proceeding by filing interrogatories and filing final written submissions.

We trust that this approach maximizes efficient use of resources and the right of otherwise unrepresented DER, electric vehicle and related ratepayers to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

DRC respectfully requests a full award of eligible costs.
