Amendment to Collus PowerStream Corp. Electricity Distribution Licence for Collus PowerStream Corp.

ED-2002-0518

On October 1, 2018, the Town of Collingwood (the "Town") and EPCOR Collingwood Distribution Corp. ("EPCOR") completed the sale by the Town of all of the shares of Collingwood PowerStream Utility Services Corp. ("CollusHoldco"), the holding company of Collus PowerStream Corp. ("CollusLDC"), to EPCOR. Board approval was received for these transactions in the Board's decision and order dated August 30, 2018 in EB-2017-0373/EB-2017-0374.

The shares of CollusHoldco were previously held 50% by the Town and 50% by Alectra Utilities Corporation. In an initial transaction, the Town acquired the remaining 50% interest of CollusHoldco from Alectra Utilities Corporation. EPCOR now holds all of the issued and outstanding shares of CollusHoldco, which holds all of the issued and outstanding shares of CollusLDC. In order to reflect this change of ownership, EPCOR has filed articles of amendment with the Ontario Corporate Registry to change the name of CollusLDC to EPCOR Electricity Distribution Ontario Inc. ("EEDO"). Accordingly, EPCOR requests that the electricity distribution licence currently held in the name of CollusLDC¹ be amended to change the licensee name to EPCOR Electricity Distribution Ontario Inc.

Please find attached to this letter:

- Articles of amendment of EEDO reflecting the name change; and
- Diagrams depicting the share ownership of CollusHoldco before and after the transaction.

Pursuant to section 21(4) of the Ontario Energy Board Act, 1998, EPCOR requests that the Board proceed with this amendment without a hearing and consents to disposing of this proceeding without a

Figure 1: Sale of Remaining 50% of Shares by Alectra Utilities Corporation to the Town




Figure 2: Sale of 100% of the Shares by the Town to EPCOR




Figure 3: Post-closing Structure for EEDO
