**Application for electricity distribution rates effective
May 1, 2023**

**PROCEDURAL ORDER NO. 1
December 16, 2022**

Wasaga Distribution Inc. (Wasaga Distribution) filed an updated incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on November 22, 2022, under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to its electricity distribution rates to be effective May 1, 2023. Wasaga Distribution is also seeking approval to adjust its Low Voltage Service rates.

A Notice of Hearing was issued on November 29, 2022. No parties applied for intervenor status.

At this time, the OEB is making provision for the filing of interrogatories, responses to interrogatories and written submissions. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. OEB staff shall request any relevant information and documentation from Wasaga Distribution that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Wasaga Distribution by **January 9, 2023**.
2. Wasaga Distribution shall file with the OEB complete written responses to the interrogatories by **January 23, 2023**.
3. Any written submissions by OEB staff shall be filed with the OEB by **February 6, 2023**.
4. Wasaga Distribution may file a written reply submission with the OEB by **February 20, 2023**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or

any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
