Re: Wataynikaneyap Power LP Application for Approval of Modifications to OEB's Form of Transmission Connection Agreement for Load Customers, Amendments to Transmission Licence and Transmission Connection Procedures

OEB File Number EB-2022-0330

The Ontario Energy Board (OEB) received an application from Wataynikaneyap Power GP Inc. on behalf of Wataynikaneyap Power LP (together, "WPLP"), on December 16, 2022, for the following:

- Approval to use certain terms and conditions in its Connection Agreement (with Hydro One Remote Communities Inc.) other than those set out in the OEB's standard form of Connection Agreement for load customers provided in Appendix 1 (Version A) of the Transmission System Code (TSC), on a final basis;
- 2. Amendments to Schedule 2 of WPLP's electricity transmission licence (ET-2015-0264) to: (i) extend certain TSC exemptions and effective dates that were approved in the OEB's EB-2022-0199 Decision and Order; and (ii) provide an exemption from section 6.2 of the TSC; and

3. Approval of WPLP's Transmission Connection Procedures, in accordance with Section 2(b) of WPLP's Transmission Licence and the requirements set out in sections 6.1.3 to 6.1.6 of the TSC.

The OEB has assigned file number EB-2022-0330 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

If required, OEB staff will contact you directly to seek clarification regarding the application and/or request additional information or material to complete the application. For these purposes, OEB staff may contact you by email, regular mail, or by telephone. Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
