DECISION ON COST ELIGIBILITY

On July 2, 2008, the Ontario Energy Board (the “Board”) issued a letter to interested parties giving notice of the consultation process that the Board intends to use in relation to the examination of its policies, programs or other measures associated with low income energy consumers in relation to their use of natural gas and electricity. That letter also described the process the Board intends to use for this consultation and indicated that cost awards would be available to eligible persons under section 30 of the *Ontario Energy Board Act, 1998* in relation to their participation in this consultation process, and that any costs awarded would be recovered from all licensed electricity distributors and all gas distributors.

Fifty-one interested parties have indicated their interest in participating in this consultation process. A list of all registered participants is attached as Appendix A to this Decision.
