Gosfield Wind Limited Partnership has applied to the Ontario Energy Board for an electricity generation licence. The granting of this licence would enable the applicant to generate electricity in Ontario.

The application will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The employee does not intend to provide for an award of costs when deciding this application.

How to participate in the hearing

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing for this application, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by August 3, 2009.

If you wish to participate in a written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submission to the Board and one copy to the applicant. All submissions must be received by August 6, 2009. If the applicant wishes to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions by August 13, 2009.

All submissions must quote the relevant file number, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.

Information relating to the application is available for viewing at the Board's offices at the address provided below or by contacting the applicant. The address and contact information for the applicant are also provided below.

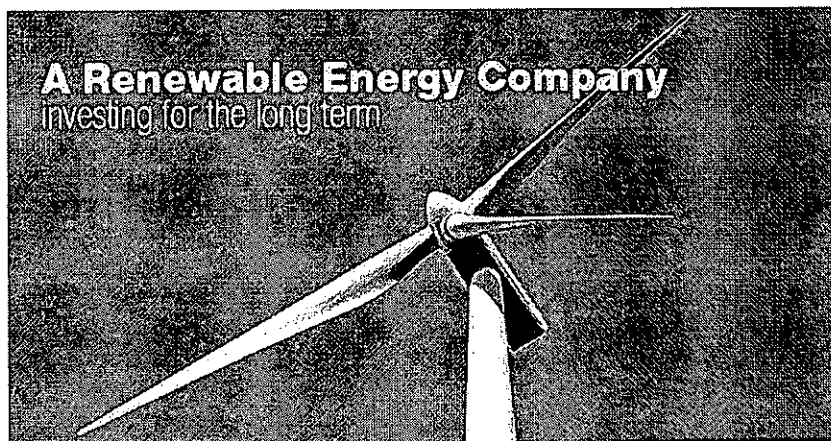

Gosfield Wind Project Awarded 20-year Contract

Having secured a 20-year power purchase agreement from the Ontario Power Authority, Brookfield Renewable Power is finalizing the design and permitting, contracting and planning for construction of a 22-turbine wind farm in the area formerly called Gosfield North. Here are some of the key steps presently underway:

- Bill Lamb, appointed as on-site construction supervisor, will move into Kingsville and coordinate construction in the field (read more about Bill next to his photo),
- We are in detailed discussions with M.A. Mortenson Company regarding the balance of plant contract for the civil aspects of the project, including road construction, foundations and wind turbine erection. Mortenson built Brookfield Renewable Power's 189 MW Prince Wind Farm in Sault Ste. Marie, one of Canada's largest wind farms.
- We selected Siemens as the wind turbine supplier

Gosfield and Comber Wind Projects

Brookfield Renewable Power, a leading producer and developer of renewable energy is proposing two wind projects in Essex County, Ontario. These two projects would generate clean, renewable energy while providing local economic benefits. Development activities and wind-data monitoring have been underway at the site for over six years, making these project two of the most mature wind projects under development in Ontario.

The Comber Wind Project is a proposed 200 MW wind project located in the Town of Lakeshore in Essex County. This project, once completed, would be capable of delivering enough electricity to power approximately 64,000 homes.

The Gosfield Wind Project is a proposed 50 MW wind project located in the Town of Kingsville, Essex County. On January 23, 2009, the Gosfield Wind Project was awarded a 20-year power purchase agreement with the Ontario Power Authority. This project, once completed, would be capable of delivering enough electricity to power approximately 16,000 homes.
