NOTICE OF INTERVENTION

1. Sithe Global Power Goreway ULC in its role as managing partner of Goreway Station Partnership (collectively, "Sithe Goreway") seeks to intervene in this proceeding for the purpose of participating in the hearing of this matter.
2. Sithe Goreway is currently constructing an 875 megawatt natural gas fuelled generating station at a site on Goreway Drive in Brampton which is located within the franchise area of EGDI and for which Sithe Goreway has executed a Gas Delivery Agreement with EGDI.
3. Sithe Goreway has an interest in those aspects of the Applications that relate to its generating station, in particular any proposed changes to EGDI's existing Rate 125 service or those new services EGDI or Union may propose as an outcome of the Natural Gas Electricity Interface Review proceeding, and such further issues as Sithe Goreway may advise once it has reviewed the evidence filed by EGDI and Union (collectively, the "Applicants").
