### Enbridge Gas Inc.

Application for leave to construct natural gas pipeline and associated facilities in the Municipality of Chatham Kent, Municipality of Lakeshore, Town of Kingsville and Municipality of Leamington

### **DECISION ON CONFIDENTIALITY**

January 27, 2023

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) on June 10, 2022, under sections 90 and 97 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B), for an order granting leave to construct approximately 19 kilometres of natural gas pipeline from its Dover Transmission Station in the Municipality of Chatham Kent to its existing pipeline in the Municipality of Lakeshore, and approximately 12 kilometres of natural gas pipeline in the Municipality of Lakeshore, Town of Kingsville and the Municipality of Leamington (Project). The Project also involves valve site station work required to tie in the proposed pipelines. Enbridge Gas also applied to the OEB for approval of the form of land-use agreements it has or will offer to landowners on the route of the Project.

## **Supplementary Questions by Three Fires Group**

On November 1, 2022, Three Fires Group wrote requesting that Enbridge Gas provide answers to supplementary questions arising out of responses Enbridge Gas provided to undertakings made in the technical conference.

The OEB, in Procedural Order No. 3, ordered that Enbridge Gas file responses to the supplementary questions from Three Fires Group by November 28, 2022.

# Request for Confidential Treatment of Certain Responses to Supplementary Questions by Three Fires Group

Enbridge Gas, in its letter dated November 28, 2022, requested that the redacted information contained in its supplementary responses to the questions submitted by Three Fires Group on November 1, 2022 be granted confidential treatment. Specifically,

Enbridge Gas requested confidential treatment of certain third party contractor work pricing/volume information in the following exhibits:

- Exhibit JT1.11 Supplementary Attachment 1, pages 2, 5, 14, 17, 20-22, and 29
- Exhibit JT1.11 Supplementary Attachment 3, pages 18 and 20
- Exhibit JT1.11 Supplementary Attachment 4, page 1

Enbridge Gas stated that the information is commercially sensitive, presumptively confidential and its disclosure could prejudice competitive positions and/or interfere with ongoing or future negotiations. Enbridge Gas filed unredacted and redacted versions of the supplementary responses in Exhibit JT1.11.

Parties that wished to make submissions on the confidentiality requests were to follow the timelines and process in sections 5.1.6, 5.1.7 and 5.1.8 of the <u>Practice Direction on Confidential Filings</u>. No parties filed submissions.

## **Findings**

The OEB has considered the confidentiality request in accordance with the <u>Practice</u> <u>Direction on Confidential Filings</u>.

The OEB finds that the redacted information on third party contractor work pricing/volume contained in Exhibit JT1.11 Attachments 1, 3 and 4 is commercially sensitive as it contains the contract pricing, fees, individual billing rates and price in the service release order, and therefore approves the redaction and confidential treatment as requested by Enbridge Gas.

### THE ONTARIO ENERGY BOARD ORDERS:

- 1. Enbridge Gas's request for the confidential treatment of the information contained in its responses to supplemental questions by Three Fires Group is approved. The information approved for the confidential treatment is redacted in the following documents:
- Exhibit JT1.11 Supplementary Attachment 1, pages 2, 5, 14, 17, 20-22, and 29
- Exhibit JT1.11 Supplementary Attachment 3, pages 18 and 20
- Exhibit JT1.11 Supplementary Attachment 4, page 1

The redacted information in these exhibits shall only be provided to individuals that have signed and filed a Declaration and Undertaking.
