

My wife and I had complaints submitted to OEB regarding home service which failed completely to address the exorbitant and continuing charges incidental to gas delivered, including but not limited to a \$20.00 per month charge for more than 10 years for 'membership'?

Which was never confirmed by the OEB as approved.

Such deviousness and failure to address is unconscionable as for the 2.2 Million Enbridge and now Union Gas consumers that amounts to an overcharge of more than \$5 Billion dollars and now they want a rubber stamped approval for a 'gas increase'?

Not on our watches!

We complained to both the Federal and Provincial Ministers, Victor Fedili who also oversees the OSC as we have real concerns about the OEB and its consumer focus, or lack thereof, and its independence as required by the Statute and the depth of independent analysis of submissions by prior alleged approvals of rates and capital costs.

We believe that the submissions of Enbridge to the OEB are not the same as submissions and filings with the OSC and with the SEC and that such constitute fraud on Ontario Consumers and fraud and/or complicity with the OEB.

The deadline for filing in Public Hearing # EB-2018-0305 for intervener status and for costs awards is February 5, 2014 and the Notice of Hearing was only published in the Vaughan Citizen on January 24, 2014/

We are of the belief that Enbridge needs to be examined under oath and that the representatives of the OEB currently and if available, who were involved in historic decisions regarding rates and, formulas and capital costs but examined under oath so that Justice be seen to be done and so that Justice be done for the citizens of Ontario who are Enbridge and now Union Gas and their subsidiaries and should the OSC and Federal Minister of Finance and the SEC be willing to attend with us, their examination on the record of audited information provided them support of legal audited filings be examined.



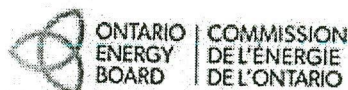
