Natural Gas Rates Have Changed

For **Residential Customers** who purchase their gas supply from **Enbridge Gas Distribution**

The Ontario Energy Board ("OEB") has approved changes to Enbridge Gas Distribution's rates effective October 1, 2017. A typical residential homeowner will see an annual decrease on their bill of about \$51.

I he decrease is primarily due to lower natural gas prices in North America. The chart on the back provides a breakdown of the annualized changes. The total effect on your bill will depend on how much gas you use.

The Gas Supply and Transportation to Enbridge charges are based on North American market prices and established transportation prices. We pass these costs on to customers with no mark-up.

The Customer and Delivery to You charges recover fixed costs for infrastructure and customer service, as well as a regulated rate of return. As of January 1, 2017, Delivery to You includes applicable charges from the Ontario government's cap and trade program. These costs relate to greenhouse gas emissions from the natural gas you use and that we use to deliver it to you. To learn more, visit **enbridgegas.com/capandtrade**.

Gas Supply Charge

The Gas Supply Charge has decreased from 12.0636 cents per cubic metre (" ϕ /m³") to 9.8252 ϕ /m³. The Gas Supply component of the Cost Adjustment is currently a charge of 0.7328 ϕ /m³. This charge, combined with the Gas Supply Charge, results in a new total effective Gas Supply rate of 10.5580 ϕ /m³.

Transportation to Enbridge

The Transportation charge has decreased by approximately \$2.03 per year for a typical customer due to lower costs for transporting natural gas to Ontario.

Delivery to You

The Delivery charge has decreased by approximately \$3.31 per year for a typical customer due to lower delivery related costs.

The OEB-approved interim cap and trade rate remains at 3.3518 ¢/m³. That represents no change on a customer's annual bill.

Cost Adjustment

The total Cost Adjustment charge is 0.6390 ¢/m³, effective until September 30, 2018. Please see the chart on the reverse for the breakdown by component.

Site Restoration Clearance

The Site Restoration Clearance refund remains at 1.1277 ¢/m³, effective until December 31, 2017. It reflects changes in an estimate of ongoing and future site restoration costs. Site restoration costs are incurred when gas distribution pipelines are replaced or retired over the life of the gas distribution system.

Rate Adjustment

The OEB has also previously approved a Rate Adjustment to reflect the difference between the amount customers paid for volumes consumed from January 1, 2016 to December 31, 2016 and the actual costs incurred. For a typical residential customer, this adjustment will be a charge of about \$8, which will appear on their October and November bills in two equal installments of about \$4.

Les prix du gaz naturel ont changé

Pour **les abonnés résidentiels** qui achèlent leur gaz chez **Enbridge Gas Distribution**

La Commission de l'énergie de l'Ontario (« CEO ») a approuvé des changements aux tarifs facturés par Enbridge Gas Distribution à compter du **1^{er} octobre 2017**. Pour un abonné moyen de type résidentiel, ces changements équivaudront à une diminution d'environ 51 \$ par année.

La diminution est principalement attribuable à la baisse des prix du gaz naturel en Amérique du Nord. La répercussion totale de ce changement sera proportionnelle à votre consommation de gaz.

Les frais de fourniture de gaz et de transport vers Enbridge sont calculés en fonction des prix sur le marché nord-américain et des prix fixés pour le transport. Nous passons ces coûts aux abonnés sans aucune majoration.

Delivery to You

The price you pay for the natural gas you use, shown as the Gas Supply Charge on your bill, depends on the terms of your agreement with your gas marketer.

Your current bill has been calculated using the new approved rates for gas consumed from October 1, 2017. The rate chart is included in this notice.

Delivery to You

The 'Delivery to You' charge has decreased due to lower delivery related costs.

As of January 1, 2017, Delivery to You includes applicable charges from the Ontario government's cap and trade program, related to greenhouse gas emissions from the natural gas you use and that we use to deliver it to you. If you are a customer who is a Non-Large Final Emitter you will be charged a cap and trade Customer Related Charge of 3.3181 ¢/m³ and the cap and trade Facility Related charge of 0.0337 ¢/m³. If you are a Large Final Emitter you will only be charged the Facility Related Charge of 0.0337 ¢/m³. The effect on your bill will depend on how much natural gas your organization uses.

Load Balancing Charge

The Load Balancing Charge has decreased due to lower seasonal load balancing related costs.

Transportation to Enbridge

The 'Transportation to Enbridge' charge has decreased due to lower costs for transporting natural gas to Ontario.

If you have an agreement with a gas marketer that includes transportation, the related charges may appear under the marketer portion of the Enbridge bill. In this case, the change to the 'Transportation to Enbridge' charge does not apply.

Cost Adjustment

The current cost adjustment includes a charge of 0.0118 ϕ/m^3 for Load Balancing and a refund of 0.1340 ϕ/m^3 for Transportation. This cost adjustment is in effect until September 30, 2018.

Our supply prices are based on a forecast of market prices for the next 12 months. The forecast price is reviewed every three months and adjusted accordingly. If our forecasts are over or under our actual costs, the difference is refunded or collected from customers through cost adjustments.



Site Restoration Clearance

The Site Restoration Clearance refund is 0.0207 ¢/m³. It reflects changes in an estimate of ongoing and future site restoration costs. Site restoration costs are incurred when gas distribution pipelines are replaced or retired over the life of the gas distribution system.

Rate Adjustment

The OEB has also previously approved a Rate Adjustment to reflect the difference between the amount you paid for volumes consumed from January 1, 2016 to December 31, 2016 and the actual costs incurred. The total amount of the adjustment will be split over two months and appear on your October and November bills as two equal installments.
