Residential Power Purchase Agreement Price Comparison

Before you sign up, compare prices

This Price Comparison compares the price customers pay on the variable portion (i.e., the charges based on your kWh consumption) of the bill from their utility to the price for the equivalent electricity services provided through the Power Purchase Agreement (PPA). This is not a total bill comparison.

Even if you enter into a PPA, you will still pay other charges to keep your home connected to the electricity distribution system. These charges include Delivery charges as well as Taxes. Further, depending on the amount of electricity you are purchasing under the PPA, you may have to purchase additional electricity from the utility or enter into a separate agreement with a retailer to meet your monthly consumption needs.

Understanding the Price Comparison

Customers who purchase their electricity from their utility can choose to pay either Time-of-Use (TOU) or Tiered prices, and on May 1, 2023, utilities can begin offering the new Ultra-Low Overnight (ULO) price plan. Check your latest bill or contact your utility to see which price plan you are currently on. These prices can change every November.

Table A shows TOU prices, Table B shows ULO prices and Table C shows Tiered prices. All are billed by your utility and set by the Ontario Energy Board (OEB). Table D shows the PPA price offered by the energy retailer.

The information on this page and in Tables A, B and C was prepared by the OEB. Tables D and E and the "Description of PPA Offer" were prepared by the energy retailer based on instructions established by the OEB.

Before comparing prices, here are key things you need to know.

Other charges: Even if you begin to receive electricity generated from a Renewable Generation System through a PPA, you will still have to pay other charges each month to have any additional electricity delivered to your home by your utility or an energy retailer.

Additional variable charges: Additional Variable Charges include fees for electricity distribution and transmission, as well as regulatory charges. The Additional Variable Charges included in Tables A, B, C and E are a simple average of the variable charges applied by Electricity Utilities across Ontario as of < month, day, year >. The variable charges on your current bill may differ. **Time-of-Use (TOU) pricing:** Under TOU pricing, the amount you pay for electricity depends on when you use it.

The following is the typical percentage breakdown for a household using 700 kWh per month:

- 63% (or 441 kWh) during Off-Peak hours when prices are lowest
- 18% (or 126 kWh) during Mid-Peak hours when prices are higher
- 19% (or 133 kWh) during On-Peak hours when prices are highest

These patterns are reflected in Table A.

Ultra-Low Overnight pricing (ULO): Under ULO pricing, the amount you pay for electricity depends on when you use it. For example, a residential customer using 700 kWh per month:

- < <XX% (or XXX kWh) > during Ultra-Low Overnight hours every day when prices are lowest
- <XX% (or XXX kWh) > during Off-Peak hours on Weekends and Holidays
- <XX% (or XXX kWh) > during Mid-Peak hours when prices are higher
- <XX% (or XXX kWh) > during On-Peak hours when prices are highest

These patterns are reflected in Table B.

Tiered pricing: Under Tiered pricing, a customer can use a certain amount of electricity each month at a lower price. Once that limit is exceeded, the higher price applies. In the winter period (Nov. 1 – Apr. 30), the Tier 1 threshold is 1,000 kWh. In the summer period (May 1 – Oct. 31), the Tier 1 threshold is 600 kWh. The **summer** Tier 1 threshold is reflected in Table C. The tables assume the typical Ontario household's electricity use of 700 kWh per month in Tables A, B, C and any difference between what you purchase through your PPA and 700 kWh in Table E. The amount of electricity you use in a month may be different.

Description of Power Purchase Agreement (PPA) Offer and Additional Charges

Table D, Table E and the "Description of PPA Offer" were prepared by the energy retailer based on instructions established by the OEB. They have not been reviewed or approved by the OEB.

Please Note: Tables D and E are intended to provide a comparison of the price customers pay on the variable portion (i.e., the charges based on kWh consumption) of the bill from their utility to the price for the equivalent electricity distribution and services provided if you enter into a PPA. This is not a total bill comparison. It is important that you review and understand the terms of the PPA and the information in the Disclosure Statement in order to understand the Net Metering Agreement and this Price Comparison.

** Note: Average Electricity Cost consists of the kWh you buy from your Electricity Utility multiplied by the average cost of a kWh in Ontario. TOU, ULO and Tiered consumption estimates in Tables A, B and C are based on the consumption patterns described on page 2; however, under net metering your usage pattern may differ based on many factors, such as when you consume electricity generated by the Renewable Energy System and when you buy from and send power to the grid.

⁺ If your Final Variable Charge Monthly Total is \$0 (i.e., you did not buy any electricity from your utility), credits accumulated will not be applied to the current bill and your utility will apply any accumulated credits on an ongoing basis for up to 12 months. Your net metering credits expire after 12 months without being applied to an electricity line.





You can change your mind.

Note: Cancellation of the PPA may give rise to penalties or other charges payable under the Associated Equipment Agreement (AEA). Be sure to read the terms of the AEA carefully.

You can cancel the PPA with no penalty associated with the PPA itself:

- Within 10 days after entering into a PPA;
- Within **30 days** after you receive your second bill under the PPA. You will still have to pay the bill.

You can cancel any time after that, but there may be a cancellation fee. Review your PPA carefully for all cancellation details.

Confirming the PPA

You will be contacted **10 – 45 days** after you've entered into the PPA to verify that you wish to continue with it. If you do not want to continue with the PPA, you can say so. You will not have to pay a cancellation fee associated with the PPA's cancellation, though cancellation of the PPA may give rise to penalties or fees outlined in the AEA.
