Application for rates and other charges to be effective May 1, 2023

1. OVERVIEW

The Ontario Energy Board is approving changes to the rates that ERTH Power Corporation (ERTH Power) charges to distribute electricity to its customers, effective May 1, 2023.

ERTH Power maintains two separate rate zones. As a result of this Decision and Rate Order, there will be a monthly total bill increase of \$4.90 in ERTH Power's Main rate zone, and \$5.42 in its Goderich rate zone, for a residential customer consuming 750 kWh. This change does not factor in applicable taxes or the Ontario Electricity Rebate.

2. CONTEXT AND PROCESS

On December 20, 2018, the OEB approved the amalgamation between ERTH Power Corporation and the former West Coast Huron Energy Inc.¹ In accordance with the OEB's decision and order approving the amalgamation, ERTH Power maintains two separate rate zones. These are the Main rate zone, which represents the legacy service territory of the former Erie Thames Powerlines, and the Goderich rate zone, which represents the legacy service territory of the former West Coast Huron Energy. ERTH Power will continue to operate with two rate zones until such time as rates are rebased and approved on a harmonized basis by the OEB.

ERTH Power serves approximately 24,000 mostly residential and commercial electricity customers in Port Stanley, Aylmer, Belmont, Ingersoll, Thamesford, Otterville, Norwich, Burgessville, Beachville, Embro, Tavistock, Mitchell, Dublin, Clinton, and the Town of Goderich.

ERTH Power filed its application on November 23, 2022 under section 78 of the *Ontario Energy Board Act, 1998* and in accordance with Chapter 3 of the OEB's *Filing Requirements for Incentive Rate-Setting Applications*. The elements of this application pertaining to both rate zones are based on the Price Cap Incentive Rate-setting (Price Cap IR) option. ERTH Power is transitioning its Goderich rate zone from the Annual IR Index rate-setting method to the Price Cap IR option, as part of this application.²

The Price Cap IR option is one of three incentive rate-setting mechanisms (IRM) approved by the OEB.³ It involves the setting of rates through a cost of service application in the first year and mechanistic price cap adjustments which may be approved through IRM applications in each of the ensuing adjustment years.

The OEB follows a standardized and streamlined process for hearing IRM applications filed under Price Cap IR. In each adjustment year, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements. A distributor will then review, complete, and include the model with its application, and may update the model during the proceeding to make any necessary corrections or to incorporate new rate-setting parameters as they become available.

The application was supported by pre-filed written evidence and a completed Rate Generator Model and, as required during the proceeding, ERTH Power updated and clarified the evidence.

3. DECISION OUTLINE

Each of the following issues is addressed in this Decision and Rate Order, together with the OEB's findings.

- Annual Adjustment Mechanism
- Shared Tax Adjustments
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts

Instructions for implementing ERTH Power's new rates and charges are set out in the final section of this Decision and Rate Order.

This Decision and Rate Order does not address rates and charges approved by the OEB in prior proceedings, such as specific service charges⁴ and loss factors, which are out of the scope of an IRM proceeding and for which no further approvals are required to continue to include them on the distributor's Tariff of Rates and Charges.

4. ANNUAL ADJUSTMENT MECHANISM

ERTH Power has applied to change its rates, effective May 1, 2023, based on a mechanistic rate adjustment using the OEB-approved **inflation minus X-factor** formula applicable to IRM applications. The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.⁵

The components of the Price Cap adjustment formula applicable to both of ERTH Power's rate zones are set out in the table below. Inserting these components into the formula results in a 3.40% increase to ERTH Power's rates: **3.40% = 3.70% - (0.00% + 0.30%)**.

An inflation factor of 3.70% applies to all IRM applications for the 2023 rate year.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that varies among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income. The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all IRM applications for the 2023 rate year. The stretch factor component of the X-factor is distributor-specific. The OEB has established five stretch factor groupings, ranging from 0.00% to 0.60%. The stretch factor assigned to any distributor is based on the distributor's total cost performance as

benchmarked against other distributors in Ontario. The stretch factor assigned to ERTH Power for both rate zones is 0.30%, resulting in a rate adjustment of 3.40%.

As part of the decision approving the amalgamation (MAADs decision), the OEB approved ERTH Power's request to maintain their pre-existing rate plans for ERTH Power's Main rate zone (Price Cap IR Index) and Goderich rate zone (Annual IR Index).⁹

Subsequent to the MAADs decision, the OEB issued a letter which, among other matters, permitted distributors that are on the Annual IR Index rate-setting plan and in a current deferral period, arising out of consolidation, to move to the Price Cap IR plan for 2023 rates. ¹⁰ As part of this application, ERTH Power requested approval to transition its Goderich rate zone from an Annual IR Index plan to a Price Cap IR plan, effective May 1, 2023.

Findings

The OEB approves the move to a Price Cap IR plan effective May 1, 2023 for the Goderich rate zone.

ERTH Power's request for 3.40% rate adjustments for both rate zones is in accordance with the annually updated parameters set by the OEB. The adjustments are approved, and ERTH Power's new rates shall be effective May 1, 2023.

5. SHARED TAX ADJUSTMENTS

In any adjustment year of an IRM term, a change in legislation may result in a change to the amount of taxes payable by a distributor. The impacts of such legislated tax changes are shared equally between shareholders and customers. The shared tax change amount, whether in the form of a credit or a debit, will be assigned to customer rate classes in the same proportions as the OEB-approved distribution revenue by rate class from the distributor's last cost of service proceeding.

For the Main rate zone, the application identifies a total tax decrease of \$2,920, resulting in a shared amount of \$1,460 to be refunded to ratepayers. For the Goderich rate zone, the application identifies a total tax decrease of \$6,503, resulting in a shared amount of \$3,252 to be refunded to ratepayers.

For both rate zones, the allocated tax-sharing amounts do not produce a rate rider to the fourth decimal place, in one or more rate classes. In such situations where the Rate Generator Model does not compute rate riders, distributors are required to transfer the entire OEB-approved tax sharing amount into the Disposition and Recovery of Regulatory Balances Control Account (Account 1595) for disposition at a later date.

Findings

The OEB approves the tax-sharing credit of \$1,460 for the Main rate zone, and tax-sharing credit of \$3,252 for the Goderich rate zone.

For the Main rate zone and the Goderich rate zone, as the allocated tax-sharing amounts do not produce a rate rider in one or more rate classes, the OEB directs ERTH Power to transfer these amounts into each respective rate zone's Account 1595 (2023).

6. RETAIL TRANSMISSION SERVICE RATES

ERTH Power's Main rate zone is partially embedded within Hydro One Networks Inc.'s distribution system. The Goderich rate zone is transmission connected.

To recover its cost of transmission services, ERTH Power requests approval to adjust the retail transmission service rates (RTSRs) that it charges its customers in accordance with the Uniform Transmission Rates (UTRs) and host distributor RTSRs currently in effect.

Findings

ERTH Power's proposed adjustment to its RTSRs for each rate zone is approved. The RTSRs have been adjusted based on the current OEB-approved UTRs and host-RTSRs. 12

UTRs and host-RTSRs are typically approved annually by the OEB. In the event that new UTRs and host-RTSRs take effect during ERTH Power's 2023 rate year, any resulting differences (from the prior-approved UTRs and host-RTSRs) are to be captured in Retail Settlement Variance Accounts 1584 (Retail Transmission Network Charge) and 1586 (Retail Transmission Connection Charge).

7. GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts to determine whether those balances should be disposed. OEB policy states that Group 1 account balances should be disposed if they exceed, on a net basis (as a debit or credit), a pre-set disposition threshold of \$0.001 per kWh, unless a distributor justifies why balances should not be disposed. If the net balance does not exceed the threshold, a distributor may still request disposition. If

Included in the Group 1 accounts are certain variances related to costs that are paid for by a distributor's customers on different bases, depending on their classification. Namely, "Class A" customers, who participate in the Industrial Conservation Initiative, pay for Global Adjustment (GA) charges based on their contribution to the five highest Ontario demand peaks over a 12-month period. "Class B" customers pay for GA charges based on their monthly consumption totals, either as a standalone charge or embedded in the Regulated Price Plan (RPP). 15 A similar mechanism applies to Class A and Class B customers for Capacity Based Recovery (CBR) charges. 16 The balance in the GA variance account is attributable to non-RPP Class B customers and is disposed through a separate rate rider. The balance in the CBR Class B variance account is attributable to all Class B customers.

ERTH Power had Class A customers during the period in which variances accumulated so it has applied to have the balance of the CBR Class B variance account disposed through a separate rate rider for Class B customers to ensure proper allocation between Class A and Class B customers.

During the period in which variances accumulated, for its Main rate zone, ERTH Power had customers transition between Class A and Class B. Under the general principle of cost causality, customer groups that cause variances that are recorded in Group 1 accounts should be responsible for paying (or receiving credits) for their disposal. ERTH Power has proposed to allocate a portion of the GA and CBR Class B balances to its transition customers, based on their customer-specific consumption levels.¹⁷ The

amounts allocated to each transition customer are proposed to be recovered (or refunded, as applicable), by way of 12 equal monthly installments.

Background

In ERTH Power's 2018 rates proceeding for the Main rate zone, the 2015 to 2016 Group 1 account balances were approved for disposition on an interim basis, as the OEB suspended disposition of Group 1 accounts on a final basis for all distributors, pending the development of accounting guidance in this matter. ^{18,19} In ERTH Power's 2018 rates proceeding for the Goderich rate zone, the OEB denied disposition of the 2015 to 2016 balances in Accounts 1588 and 1589, citing concerns with the distributor's RPP settlement true-up process. ²⁰ The OEB also stated that it would conduct an audit of the account balances for 2015 and 2016, including a review of the new true-up process that commenced in 2017, prior to disposing of these amounts on a final basis.

In ERTH Power's 2019 rates proceeding for the Main rate zone, the 2017 Group 1 account balances were approved for disposition on an interim basis. ²¹ In ERTH Power's 2019 rates proceeding for the Goderich rate zone, the 2017 Group 1 account balances were approved for disposition on an interim basis, with the exception of Accounts 1588 and 1589 which were not disposed, as the OEB's review of those accounts and the distributor's settlement process was still underway. ²²

In ERTH Power's 2020 rates proceeding, the OEB denied ERTH Power's request to dispose of the 2018 balances in Accounts 1588 and 1589, for the Main rate zone, due to concerns with those balances. The OEB stated that, as an audit was recently completed for the Goderich rate zone, ERTH Power should apply any insights from that review to its Main rate zone, to help support the accuracy of the balances in Accounts 1588 and 1589. The OEB approved disposition of the remaining 2018 Group 1 account balances an interim basis. The OEB also provided direction to ERTH Power regarding the need to address concerns over the balances in question, as well as with respect to implementation of the OEB's accounting guidance on commodity pass-through accounts. For the Goderich rate zone, as the OEB inspection of the 2016 to 2017 Account 1588 and 1589 balances had concluded, the OEB approved disposition of

those amounts, as well as the 2018 balances for all Group 1 accounts, on an interim basis.

In ERTH Power's 2021 rates proceeding, ERTH Power requested to defer disposition of the 2018 and 2019 balances in Accounts 1588 and 1589, for the Main rate zone, as well as the 2019 balances of those accounts in the Goderich rate zone, as it was undertaking a review of the historical balances in those accounts in response to the OEB's direction in its 2020 rates proceeding.²⁵ The OEB accepted ERTH Power's request. The OEB also reminded ERTH Power of the OEB's expectations with respect to retrospective adoption of its accounting guidance, and instructed ERTH Power to provide evidence substantiating the reasonability of the Account 1588 and Account 1589 balances before requesting disposition.

In ERTH Power's 2022 rates proceeding, ERTH Power explained that, as a result of undertaking its review of historical balances in Accounts 1588 and 1589, it identified a billing inconsistency matter with the IESO, and at the time, was still resolving the issue. The OEB accepted ERTH Power's request to defer disposition of Accounts 1588 and 1589, for both rate zones.²⁶ The remaining Group 1 account balances, accumulated during the 2020 calendar year, did not meet the OEB's disposition threshold, and so the OEB approved deferring disposition of those amounts as well.

In the current proceeding, ERTH Power explained that it has completed an exhaustive review of all of balances and validated that the amounts requested for disposition from its customers are accurate and appropriate. Through this review, ERTH Power states that it has been able to determine inaccuracies in its filings with the IESO and has implemented these adjustments by year. ERTH Power has also through this process been able to confirm the accuracy of its GA allocations between RPP and Non-RPP customers to ensure that the balances being disposed of will be recouped through the appropriate customer segment. ERTH Power confirmed that it has implemented the OEB's accounting guidance for each applicable year as directed to so by the OEB.²⁷ ERTH Power further confirmed that it has fully implemented the OEB's direction in the decision and order for 2022 rates.²⁸ ERTH Power also noted that it has applied the lessons learned from the OEB's audit of its Goderich rate zone to the Main rate zone. ERTH Power stated that it now assesses the commodity units purchased in the General Ledger for each month for reasonability by comparing them to the IESO posted rates

and it conducts annual reviews for both Accounts 1588 and 1589 to ensure adjustments are posted to the proper months.²⁹

ERTH Power stated that it is confident that processes are in place to ensure the accuracy of the commodity account balances, including the historical data filed in this proceeding. ³⁰ ERTH Power requested disposition of the Group 1 balances on an interim basis so that, in the unlikely event that errors are found, it will have the opportunity to make corrections. ³¹

Main Rate Zone

The 2021 year-end net balance for the Main rate zone's Group 1 accounts eligible for disposition, including interest projected to April 30, 2023, is a debit of \$3,249,562. This amount pertains to variances accumulated from the 2018 to 2021 calendar years for Accounts 1588 and 1589, and for the remaining Group 1 accounts, variances accumulated from the 2020 to 2021 calendar years. This amount represents a total claim of \$0.0065 per kWh, which exceeds the disposition threshold. ERTH Power has requested the disposition of this amount over two years to mitigate bill impacts, for all customers paying for these balances, associated with four years of variances being disposed.³²

Goderich Rate Zone

The 2021 year-end net balance for the Goderich rate zone's Group 1 accounts eligible for disposition, including interest projected to April 30, 2023, is a debit of \$325,340 and pertains to variances accumulated from the 2019 to 2021 calendar years for Accounts 1588 and 1589, and for the remaining Group 1 accounts, variances accumulated from the 2020 to 2021 calendar years. This amount represents a total claim of \$0.0024 per kWh, which exceeds the disposition threshold. ERTH Power has requested the disposition of this amount over a one-year period.

Findings

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.

The OEB approves the disposition of a debit balance of \$3,249,562 as of December 31, 2021, including interest projected to April 30, 2023, for the ERTH Power Main rate zone's Group 1 accounts on a final basis. The OEB accepts ERTH Power's proposal to

recover these amounts over a 24-month period in order to mitigate bill impacts. The OEB approves the disposition of a debit balance of \$325,340 as of December 31, 2021, including interest projected to April 30, 2023, for the ERTH Power Goderich rate zone's Group 1 accounts on a final basis.

While ERTH Power has requested interim disposition, the OEB will not dispose balances on an interim basis unless there is a reason to do so. The preservation of the opportunity to make corrections in a future period is not a persuasive one to the OEB, particularly when no such adjustments are currently anticipated.

ERTH Power has expressed its confidence in the accuracy of the amounts being disposed and based on the record in this proceeding, the OEB finds that ERTH Power has undertaken reasonable efforts to validate its claims and adequately responded to past OEB direction with respect to substantiating its Group 1 accounts. The OEB further finds that the balances requested for disposition are reasonable and notes that several cumulative years of activity are being considered. Accordingly, the OEB is approving disposition of Group 1 accounts on a final basis. In addition, the Group 1 account balances for ERTH Power's Main rate zone that were previously disposed on an interim basis (2015 to 2017 balances for Accounts 1588 and 1589, and 2015 to 2019 balances for all other Group 1 accounts) are now final. The Group 1 account balances for ERTH Power's Goderich rate zone that were previously disposed on an interim basis (2015 to 2018 balances for Accounts 1588 and 1589, and 2015 to 2019 balances for all other Group 1 accounts) are now final.

Although ERTH Power has stated that it believes such an outcome is unlikely, should an adjustment to the amounts being disposed in this or a prior proceeding be sought in the future, ERTH Power shall refer to the OEB's October 2019 guidance on errors discovered after disposition associated with pass-through variance accounts.³³ The OEB encourages ERTH Power to continue to seek out additional improvements in its processes with respect to accounting and settlement of commodity costs, to further improve the accuracy and reasonability of accounts sought for disposition in future proceedings.

Table 7.1 identifies the principal and interest amounts for the Main rate zone and Table 7.2 identifies the principal and interest amounts for the Goderich rate zone, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in the *Accounting Procedures Handbook for Electricity Distributors*. ³⁴ The date of the transfer must be the same as the effective date for the associated rates, which is generally the start of the rate year.

The OEB approves these balances to be disposed through rate riders, charges, or payments, as calculated in the Rate Generator Models. For the Main rate zone, the rate riders, charges, and payments, as applicable, will be in effect over a two-year period from May 1, 2023 to April 30, 2025. 8. IMPLEMENTATION

In the *Report of the Board: Review of Electricity Distribution Cost Allocation Policy*,³⁹ the OEB indicated that it will review the default province-wide microFIT charge annually to ensure it continues to reflect actual costs in accordance with the established methodology. On December 8, 2022, the OEB issued a letter advising electricity distributors that the microFIT charge shall remain at \$4.55 for the duration of the 2023 calendar year.
