#### **Issues:**

AMPCO intends to review the IESO's proposed expenditures (capital and operating) and revenue requirements for the fiscal years 2023-2025 and the fees it proposes to charge in each year. AMPCO also seeks to review the basis of the ISEO's request to retain \$15 million as an operating reserve in the Forecast Variance Deferral Account (FVDA).
