This correspondence is in relation to the above noted applications to the OEB (collectively referred to as the “Applications”). In each of the Applications, the OEB has issued a Procedural Order setting a date on which Enbridge Gas is to file responses to interrogatories posed by the parties to the Applications. The Procedural Orders and corresponding filing dates are as follows:

The Applications relate to community expansion of natural gas distribution systems and have a number of parties in common. As a result, some interrogatories are also common across the Applications while others are unique to the Application in which the interrogatory is filed. Enbridge Gas has received a significant number of interrogatories across the Applications (over 550 total including sub-parts) with some requiring detailed analysis. In responding to the interrogatories, Enbridge Gas’s team includes staff members that are common across the Applications as well as staff members that are unique to particular projects. Given the commonalities that exist in the nature of the Applications and in a number of interrogatories, it will be important that the Company maintains clarity and consistency in its responses to allow for efficient review by the OEB and parties.

With a desire to provide complete responses and to ensure consistency across the Applications with respect to common interrogatories, Enbridge Gas requires additional

time to provide its interrogatory responses. Enbridge Gas will be in a position to file completed responses to the interrogatories posed for the Applications on May 2, 2023, and requests that the OEB extend the filing timelines to that date for all three proceedings.
