[p. 56-57] With respect to Account 475.21 (Mains – Coated & Wrapped), Mr. Madsen recommends the use of useful life of between 63 to 65 years (63-R3 and 65-R3) but then provides an estimate of the impact based on 60 years (60-R3). Please provide the revised impact on depreciation (both based on ALG and ELG procedure) for (65-R3 curve).
