Since filing its pre-filed evidence, Enbridge Gas has refined both the Project-specific customer attachment forecast and estimated capital costs (described in Exhibits B and E, respectively). Through refinement of Project design and the underlying attachment forecast, in the normal course of project development, Enbridge Gas identified an error whereby it counted a multi-unit condo property as a single potential customer when it should have been counted as 64 potential customers. Accordingly, the total forecasted customer attachment forecast (capture rate) has been updated from 110 to 130. Additionally, more detailed designs for the pipeline main and servicing infrastructure have allowed the Company to update Project cost estimates, resulting in an overall reduction in the Project costs from approximately \$3.5 million to \$3.3 million. As a result of the refinements described above, the Project-specific DCF analysis and PI result have also been updated. Enbridge Gas has reflected these updates throughout its responses to interrogatories contained within the attached package and will file updates to select relevant excerpts of its pre-filed evidence, with changes denoted in the margins, with the OEB not later than May 5, 2023.
