Re: May 1, 2008 IRM Rate Filing / EB-2007-0829 Interrogatories

Pursuant to the OEB's request of December 13, 2007, Waterloo North Hydro Inc. (WNH) has the following responses to the Board's Interrogatories:

1. Monthly Rates and Charges for Large Use

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the "Retail Transmission Rate – Network Service Rate" on row 190 should include the descriptor "- Interval Metered".

Likewise, a review of your current 2007 Board approved Tariff of Rates and Charges indicates that the "Retail Transmission Rate – Line and Transformation Connection Service Rate" on row 191 should include the descriptor " - Interval Metered".

Response – the differences noted above were simple transcription errors and should reflect the 2007 tariff schedule of rates and charges terminology.

2. Monthly Rates and Charges for Unmetered Scattered Load

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor "(per connection)", however your 2008 model does not reflect this.

Response – the difference noted above was a simple transcription error and should reflect the 2007 tariff schedule of rates and charges terminology.

3. Monthly Rates and Charges for Street Lighting

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor "(per connection)", however your 2008 model does not reflect this.

Response – the difference noted above was a simple transcription error and should reflect the 2007 tariff schedule of rates and charges terminology.

4. Specific Customer Charges – Allowances

In row 447, Transformer Allowance for Ownership – per kW of billing demand/month, you have entered a billing determinate unit of "\$", a review of your current 2007 Boardapproved tariff sheet indicates that the unit should be "\$/kW".

Response – the differences noted above were a simple error in selecting the rating dimension from the drop-down list and should be shown as \$/kW.
