**Re: Application for Licence Amendment - Interim Exemption from
Section 6.5.4 of the Distribution System Code
Board File Number EB-2008-0149**

This letter acknowledges receipt on June 18, 2008 of the above referenced application. The Board has assigned File Number EB-2008-0149 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

The Board has conducted a preliminary review of the above noted application and requires additional information from the applicant before it proceeds in this matter. Please provide the Board with the information requested below by July 25, 2008:

1. A list of all properties that are currently served by Hydro One Networks Inc. under a long term load transfer arrangement (LTLT) for which the applicant requests an exemption from the requirements of section 6.5.4 of the Distribution System Code (DSC). The list should include both the legal descriptions and the civic addresses of the subject properties.
2. The term of the exemption sought by the applicant with respect to each property described in item #1 above.
3. Information respecting the applicant's plan to eliminate the subject LTLT arrangements. The information should include but not be limited to the following:

- a. the date by which the LTLT arrangement with respect to each identified property where the subject LTLT customers are located will be eliminated,
 - b. details of the applicant's planned method for eliminating the LTLT arrangements for each property where the subject LTLT customers are located (i.e. details of the type of system expansion, establishing a retail point of supply, etc.)
 - c. the steps taken by the applicant to date to implement its plan. If no steps have been taken to date, provide reasons.
 - d. information that compares the applicant's planned methods to other options available to the applicant to eliminate the subject LTLT arrangements from the perspective of long term economic (cost) and engineering (system planning) efficiency.
4. The specific date; to which the parties (i.e. both the geographic and the physical distributor) agreed to extend the existing LTLT arrangements for each property where the subject LTLT customers are located.
 5. A letter from Hydro One confirming the information requested in item #4 above.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
