#### NOTICE OF APPLICATION AND WRITTEN HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE

#### Orangeville Hydro Limited

The Ontario Energy Search has received an application on October 26, 2007 under section 78 or the Ontario Energy Search Act, 1996, S.O. 1996, c. 15 (Schedule B), 5 teking approval for changes to the rates that Orangeville hydro Limited charges for electricity distribusion, to be effective May 1, 2008. The Board has assigned the application file number EB-2007-0935. The Licence section on this application may have an offection all of Orangeville Hydro Limitod's customers.

Any change to the rates that Orangeville Hydro Limited charges for electricity distribution will be reflected in the delivery charges. Delivery charges are one of four regular items on residential and general service customers' electricity bills and vary depending on the amount of electricity consumed.

Orangeville rilydro Limited Indicates that if the application is approved as filled, a residential customer consuming 1,000 kWh per month would experience an epproximate 1.7% increase in the electricity bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would see an approximate 1.9% increase in the observicity pill.

# How to Participate in the Rate Proceeding

The applicant shall file with the Board complete responses to the interrogatories and deliver them to all printes who asked interrogatories no later than January

Anyone who wishes to make a submission on the application must file that written submission with the Board and deliver it to the applicant by January 10, 2008, if the ripplicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions by January
