**2008 Incentive Rate Mechanism Application
Ontario Energy Board Staff Interrogatories for
Innisfil Hydro Distribution Systems Limited – EB-2007-0845**

For each of the interrogatories below, please clarify whether this was an error, confirming what the correct entry should have been, or provide a complete explanation for the discrepancies. The format of the response should repeat the references and interrogatories.

Ref.: 2008 IRM Model, Sheet 3 (2007 Tariff Sheet)

1. Monthly Rates and Charges for General Service 50 to 4,999 kW

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the "Retail Transmission Rate – Network Service Rate" on row 176 should include the descriptor " – Interval Metered".

Likewise, a review of your current 2007 Board approved Tariff of Rates and Charges indicates that the "Retail Transmission Rate – Line and Transformation Connection Service Rate" on row 177 should include the descriptor " – Interval Metered".

Innisfil Hydro Distribution Systems Limited (IHDSL) has determined this is an error and the correction to row 176 and 177 is accomplished by adding " – Interval Metered" to each of the descriptor lines.

2. Monthly Rates and Charges for Street Lighting

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor "(per connection)", however your 2008 model does not reflect this.

IHDSL has determined this is an error and the correction to the Service Charge for Street Lighting is accomplished by adding "(per connection)" to the descriptor line.

3. Monthly Rates and Charges for Unmetered Scattered Load

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor "(per connection)", however your 2008 model does not reflect this.

IHDSL has determined this is an error and the correction to the Service Charge for Unmetered Scattered Load is accomplished by adding "(per connection)" to the descriptor line.

4. Monthly Rates and Charges for Sentinel Lighting

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge should include the descriptor "(per connection)", however your 2008 model does not reflect this.

IHDSL has determined this is an error and the correction to the Service Charge for Sentinel Lighting is accomplished by adding "(per connection)" to the descriptor line.

5. Monthly Rates and Charges for Non-Payment of Accounts

You have left blank the entry for the unit of the items in rows 415 to 420, inclusively. A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the unit for these items should be "\$".

A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the Service Charge in row 429 should be "Temporary service install and remove – overhead – with transformer".

IHDSL has determined this is an error and the correction to the unit of items in row 415 to 420 inclusively is accomplished by adding "\$" to rows 415 to 420 in the unit of the items. Further, the correction to the Service Charge in row 429 should read "Temporary service install and remove – overhead – with transformer"

6. Allowances

In row 447, you have input the billing determinant unit for "Transformer Allowance for Ownership – per kW of billing demand/month" as "\$". A review of your current 2007 Board approved Tariff of Rates and Charges indicates that the unit for this item should be "\$/kW".

IHDSL has determined this is an error and the correction to the billing determinant unit for Transformer Allowance for Ownership – per kW is accomplished by changing the bill determinant unit to "\$/kW" on row 447.
