

ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF INNPOWER CORPORATION

InnPower Corporation has applied to raise its electricity distribution rates and other charges.

Learn more. Have your say.

InnPower Corporation has applied to the Ontario Energy Board to raise its electricity distribution rates effective January 1, 2024.

If the application is approved as filed, residential customers would see no change to their monthly distribution service charge, which is capped under the provincial Distribution Rate Protection program.

A typical customer of InnPower Corporation in the General Service less than 50kW rate class would see an increase of \$1.97 per month if the application is approved as filed. Other customers, including businesses, may also be affected.

InnPower Corporation has also applied for approval of a new embedded distributor rate class, and new Specific Service charges. It is important to review the application carefully to determine whether you may be affected by these changes.

InnPower Corporation is also requesting approval of three Advanced Capital Mechanism Requests for the Barrie Area Transmission Upgrade project, if certain deferral account requests are not approved.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider InnPower Corporation's application. During this hearing, which could be an oral or written hearing, we will question InnPower Corporation on its case for a rate increase. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

Distributors such as InnPower Corporation typically apply for a full review of their rates every five years. Any rate changes for the years in between are made by applying an OEB-approved formula which is tied to inflation and other factors intended to promote efficiency. You may not get notice of future rate changes made by applying the formula.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review InnPower Corporation's application on the OEB's website now
- You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about InnPower Corporation's application and make arguments on whether the OEB should approve InnPower Corporation's request. Apply by **June 19, 2023** or the hearing will go ahead without you and you will not receive any further notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. InnPower Corporation has applied for a written hearing. The OEB will determine at a later date whether to proceed by way of a written or oral hearing. If you think an oral hearing is needed, you can write to the OEB to explain why by **June 19, 2023**.

PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B.
