You are directed:

 - Ministry of Energy;
 - Ministry of the Environment;
 - Ministry of Aboriginal Affairs;
 - Ministry of Transportation;

If the applicant is unable to serve all parties by September 4, 2008, the Board is to be informed immediately.

To file with the Board affidavit evidence proving the above service immediately upon completion, with the relevant Notice, Application and location map, and original post office registration receipts (where applicable), or courier delivery confirmation lists attached as appendices.

The affidavits of service referred to above must confirm that the Municipal Clerks served are the clerks of <u>all</u> affected municipalities, that the Native Bands and Native Reserves served are <u>all</u> of the Bands and Reserves affected, that the utilities and railway companies served are <u>all</u> utilities and railway companies whose lines would be crossed by the proposed pipeline, and that the property owners and encumbrancers and encumbrancees so served are <u>all</u> owners and encumbrancers and encumbrancees affected by the proposed construction.
