**Re: Barrie Hydro Draft Tariff of Rates and Charges  
Barrie Hydro Distribution Inc.  
2010 IRM 3 Application  
Board File Number EB-2009-0245**

Barrie Hydro Distribution Inc. (licence ED-2002-0534) filed a 2010 3<sup>rd</sup> Generation Incentive Rate Mechanism application. In the Board's Decision and Order dated April 1, 2010 on page 14, point 2, it stated; "Barrie Hydro shall review the draft Tariff or Rates and Charges set out in Appendix A. Barrie Hydro shall file with the Board a written confirmation assessing the completeness and accuracy of the draft Tariff of Rates and Charges, or provide a detailed explanation of any inaccuracies or missing information, within seven (7) calendar days of the date of this Decision and Order."

By way of this letter Barrie Hydro agrees with and confirms the completeness and accuracy of the draft Tariff or Rates and Charges as listed in Appendix A of the Board Decision and Order, after the following corrections are made:

- the tax change rate rider for General Service 50 to 4,999 kW, Large Use and Street Lighting service classifications, needs to be revised to show that this is per kW; and
- the tax change rate rider for General Service 50 to 4,999 kW of (\$0.0280) per kW needs to be added to the General Service 50 to 4,999 kW TOU service classification.

On January 1, 2009, the former Barrie Hydro Distribution Inc. and the former PowerStream Inc. were amalgamated into a single company (PowerStream Inc.) as approved by the Board (EB-2008-0335). In a Board decision (EB-2010-0025) on March 16, 2010, the distribution licence of PowerStream Inc. (ED-2004-0420) was amended to include the service territory of the former Barrie Hydro Distribution Inc. and the Barrie Hydro licence was cancelled. To reflect this decision, PowerStream requests that the name "Barrie Hydro Distribution Inc." be removed from the Tariff sheet and replaced with "PowerStream Inc. – Barrie".
