EPCOR Natural Gas Limited Partnership

Motion to review and vary EB-2022-0184 Decision and Order (Phase 2) relating to Customer Volume Variance Account, and a request for stay of the implementation of certain aspects of the Decision

PROCEDURAL ORDER NO. 3 June 22, 2023

EPCOR Natural Gas Limited Partnership (EPCOR) filed an incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on July 18, 2022, under section 36 (1) of the Ontario Energy Board Act, 1998 seeking approval for changes to its natural gas distribution rates to be effective January 1, 2023, for its South Bruce service area (Application).¹

The OEB issued a Phase 2 Decision and Order (Decision) on April 6, 2023, on the Customer Volume Variance Account requested in the Application. On May 10, 2023, EPCOR filed a notice of motion to review and vary the Decision (Motion).

On June 9, 2023, the OEB issued Procedural Order No. 2 granting EPCOR's requested two-week extension to file its argument-in-chief and updated the procedural timelines including submissions by OEB staff and intervenors to July 20, 2023.

On June 19, 2023, the Vulnerable Energy Consumers Coalition (VECC) filed a letter requesting that submissions by OEB staff and intervenors be extended to **July 27**, **2023**. The OEB grants the requested extension.

The OEB expects OEB staff and intervenor submissions to be filed with the OEB no later than **July 27, 2023**. Accordingly, the dates provided in Procedural Order No. 2 have been amended below. EPCOR's argument-in-chief filing date will remain unchanged and due on **July 6, 2023**.

The OEB will also update its tentatively scheduled virtual hearing to allow the OEB to ask any questions it may have to **August 24, 2023**. The OEB will formally schedule this event in a future procedural order, if needed.

- 2. Any reply submission by EPCOR Natural Gas Limited Partnership shall be filed with the OEB by **August 10, 2023**.
