**Application for an Electricity Retailer Licence and Gas
Marketer Licence**

INTERIM DECISION AND ORDER

Summitt Energy Management Inc. on behalf of Summitt Energy LP (Summitt Energy) submitted a request to the Ontario Energy Board (OEB) on June 21, 2023, for an interim extension to the licence term for both its electricity retailer licence ER-2018-0099 and gas marketer licence GM-2018-0100, to avoid non-compliance with sections 48 and 57 of the *Ontario Energy Board Act, 1998* (OEB Act).

Summitt Energy's electricity retailer licence ER-2018-0099 expired on June 20, 2023. In order for the applicant to perform electricity retailing activities in Ontario, the applicant requires an electricity retailer licence pursuant to section 57 of the OEB Act.

Summitt Energy's gas marketer licence GM-2018-0100 expired on June 20, 2023. To participate in the gas market, the applicant requires a gas marketer licence pursuant to section 48 of the OEB Act.

Summitt Energy became aware of the licence term expiry while preparing the licence applications forms, in accordance with section 60 of the OEB Act, for a renewal of its electricity retailer licence and section 50 of the OEB Act, for a renewal of its gas marketer licence. Summitt Energy in its request asked that the term for both licences be extended so that it may continue to operate while its licence applications are filed and considered by the OEB.

The OEB finds it expedient to extend the term of both existing licenses on an interim basis, considering the applicant's need for both licenses to continue carrying out activities as an electricity retailer and a gas marketer, pending the final disposition of the matter. The OEB expects Summitt Energy to complete the application process expeditiously so that the application review process can commence. This Decision and Order does not constitute a final decision on the application.

IT IS ORDERED THAT:

1. The term of Summitt Energy Management Inc. on behalf of Summitt Energy LP's electricity retailer licence ER-2018-0099 is extended on an interim basis until October 1, 2023, or until the final determination of the electricity retailer licence application, whichever is earlier. The conditions of licence remain unchanged.

2. The term of Summitt Energy Management Inc. on behalf of Summitt Energy LP's gas marketer licence GM-2018-0100 is extended on an interim basis until October 1, 2023, or until the final determination of the gas marketer licence application, whichever is earlier. The conditions of licence remain unchanged.
