NOTICE OF APPLICATION

SUN-CANADIAN PIPE LINE COMPANY LIMITED EXEMPTION FROM LEAVE TO CONSTRUCT TO RELOCATE A HYDROCARBON PIPE LINE IN THE CITY OF SARNIA, ONTARIO

Sun-Canadian Pipe Line Company Limited ("Sun-Canadian") has filed an application with the Ontario Energy Board, (the "Board") dated July 31, 2008 under section 95 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B for an exemption from the Board's Leave to Construct requirements to relocate a hydrocarbon pipeline. A redacted version of the application was filed with the Board dated August 15, 2008.

The Board has assigned File No. EB-2008-0270 to this application.

The proposed 0.76 km of relocated NPS 12 steel pipeline will connect with an existing pipeline located just east of Sun-Canadian's Sarnia Pump Station and west of Vidal Street and will proceed northeast for 0.15 km to a point just south of the River Road/Vidal Street overpass. At that point the line will turn and run parallel to the CSX Transportation Inc's railroad for approximately 0.14 km where it will turn and cross the CSX railroad and proceed 0.40 km northeasterly in the City of Sarnia's road allowance for 0.40 km. The line will cross over Vidal Street for 0.05 km and tie in to the existing main pipe line at that point. A map showing the location of the proposed route is attached as Appendix "A" to this Notice.

The Board intends to proceed with the application by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary by

September 10, 2008. That objection must be filed with the Board and copied to the applicant. The applicant may respond to this objection by September 12, 2008.

Any party wishing to file a submission in this case must do so no later than September 16, 2008. The Submission must be filed with the Board and copied to the applicant.

If the applicant wishes to respond to the submission, it must do so by September 19, 2008. The submission must be filed with the Board and copied to all parties making submissions.

All filings to the Board must quote file number EB-2008-0270, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and email address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to BoardSec@oeb.gov.on.ca. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

IF YOU DO NOT FILE A WRITTEN SUBMISSION OBJECTING TO A WRITTEN HEARING OR DO NOT PARTICIPATE IN THE HEARING BY FILING WRITTEN SUBMISSIONS IN ACCORDANCE WITH THIS NOTICE, THE BOARD MAY PROCEED WITHOUT YOUR PARTICIPATION AND YOU WILL NOT BE ENTITLED TO FURTHER NOTICE IN THIS PROCEEDING.
